2. MINUTES OF PREVIOUS MEETING

The minutes of Oban, Lorn & the Isles CHORD meeting held on 2nd December 2009 were approved as a correct record.

3. OBAN BAY / HARBOUR - FULL BUSINESS CASE

Paul Finch provided a further executive summary presentation to members in regard to the technical financial and other operational constraints around the proposed development at Oban Bay for a marina development.

Decision

- 1. To recommend to the CHORD Project Management Board that the Oban Bay Marine Project is not progressed due to the technical, financial and operational constraints highlighted by the consultants.
- 2. To agree that the technical report be released to Oban Bay Marine via John MacGregor now that the Project Board were happy with the terms of the report prepared by AECOM. The Board recognised that parts of the FBC were commercially sensitive.
- 3. To note that the remaining options in the PID for Oban Bay would now be explored by the Project Board

To note that the Project Board wished to arrange a meeting with the board members of Oban Bay Marine on 5 January 2010 at 2.30pm in the Kerrera Suite, Corran Halls, Oban to explain to those board members the reasons behind the decision taken at 1 to include a presentation by the consultants on the issues which affected the feasibility and viability of the project.
