MINUTES of MEETING of MID ARGYLL, KINTYRE AND THE ISLANDS LOCAL AREA COMMUNITY PLANNING GROUP held in the TOWN HALL, CAMPBELTOWN on WEDNESDAY, 2 NOVEMBER 2011

The Chair welcomed everyone to the meeting and Iain Jackson explained that the Chief Executive and Leader of the Council would be attending to present the budget item. He stated that they were currently attending the Community Planning Partnership in Lochgilphead and would therefore arrive at a later stage. As a result, he advised that the order of business would be altered to accommodate this.

Councillor Semple commented that attendees could have scheduled their attendance in order to be present for a specific item and that this could hinder their arrangements.

Councillor Kelly queried why there were no papers circulated for the budget item. It was explained that this was a presentation and therefore there were no papers. Councillor Kelly then asked whether there would be feedback following the consultation. Douglas Hendry stated that there would be feedback to the LACPGs.

1. APOLOGIES

Apologies were received from:

Yvonne Litster, ACHA Kate Macaulay, NHS Highland Jeanette Laughton, Ardrishaig Community Council Marlene Baillie, Strathclyde Police Councillor Robin Currie, Argyll and Bute Council

2. DECLARATIONS OF INTEREST

Councillor Colville declared a non-financial interest in relation to item 4 **(South Kintyre Development Trust)** as he is a director of the trust. As this was just an update, he indicated that he did not feel it necessary to leave the meeting during discussion of the item.

3. MINUTES OF THE PREVIOUS MEETING HELD ON 7 SEPTEMBER 2011

Arising from item 4 (ACHA – Priorities and Activities) Councillor Horn advised that she had not yet received a response from Yvonne Lister. It was agreed to raise this with ACHA.

Arising from item 5 (Outcome of Community Planning Self Assessment Exercise) Councillor Semple commented that he had expressed concern at the meeting regarding the late receipt of reports which he had hoped would have been minuted. It was agreed to amend the minute to incorporate this.

Subject to the amendment regarding receipt of late papers, the Minutes of the previous meeting held on 7 September 2011 were approved as a true and correct record.

4. SOUTH KINTYRE DEVELOPMENT TRUST

Malcolm MacMillan gave a presentation to Members updating them on the South Kintyre Development Trust.

He advised that a survey had been circulated consisting of 4 questions relating to communities; what was liked about them; not liked about them; inviting suggestions for improvement; and prioritising these suggestions.

Malcolm outlined the response rates for the Community Council areas, which were particularly encouraging and spoke about the results of the survey. He then discussed the next steps which were to interview stakeholders to inform the plan and indicated that there would be events held over the coming months to promote the survey and develop an action plan that would be worked up over the coming years.

The Chair thanked Malcolm for the informative update.

ACTION: Agreed that information regarding reviewing Community Council boundaries would be circulated to the Group and that at an appropriate time, the South Kintyre Development Trust should submit Highlight/Exceptions reports to keep the Group informed of progress.

5. OPERATION OF INTEGRATED CARE TEAMS

It was explained by lain Jackson that he had been informed that this issue was currently under discussion and a request had been received to continue this to a future meeting. This was agreed by the Group.

6. CONSULTATION DIARY - ARGYLL AND BUTE COUNCIL, IMPROVEMENT AND STRATEGIC HR

lain Jackson advised that this item served as a reminder that there was a diary in place and invited partners to feed into this should they be conducting, or become aware of a consultation.

7. UPDATES FROM THEMATIC GROUPS

lain Jackson advised that the reports were there for noting or any questions which the Group wished to raise.

Susan Paterson commented that the reports were old and did not give any information. Councillor Semple agreed and commented that there appeared to be a missing link in that these reports did not seek the views of community groups.

ACTION: The Group agreed that the reports from the Thematic Groups required to be more up to date with matters relevant to the LACPGs to allow engagement.

8. UPDATE ON RENEWABLES

Audrey Martin advised that the Renewable Energy Action Plan (REAP) had been agreed in June 2010 and set out the key actions to take forward. This plan was due to be reviewed this year with input from the Highlands and Islands Partnership and the Community Planning Partnership.

She provided information on the 3 tidal lease sites at Portnahaven, Kintyre and Sound of Sanda, discussed key elements to take forward renewable projects in Argyll and Bute, community trust funds (details of which could be located on the Council's website) and sub sea cables which she advised there would be a delay in the laying of.

There was a discussion about community involvement on the Argyll and Bute Renewables Alliance (ABRA). Audrey replied that there was assistance for communities by the ABRA partners although there were no specific community group representatives given the strategic nature of ABRA.

Suggestions were made as to methods to address community engagement. Audrey advised that this was a critical area to look at although perhaps through the Third Secord and Communities Group or Social Enterprise Network. She offered to come back to the Group at an appropriate time regarding this.

9. HM QUEEN'S DIAMOND JUBILEE BEACONS

lain Jackson advised that this item was in relation to an email previously circulated by Stephen Doogan to Community Councils. He requested that, for the Community Councils who wish to participate, contact be made with Stephen who would then co-ordinate details in order to notify appropriate authorities.

10. REVISED SINGLE OUTCOME AGREEMENT/COMMUNITY PLAN

lain Jackson provided the Group with an update from Jane Fowler and Eileen Wilson. He advised that a decision on the Single Outcome Agreement (SOA) was under discussion by the Management Committee following the self assessment. There was an intention to take this to the Thematic Groups and then onwards to LACPG meetings in January.

Councillor Semple stressed that it was important that any report was seeking views and not provide an update. He stated that this must be made available in advance of the meeting for consideration of the Group.

11. RATIONALISATION/PARTNERSHIP LINKAGES TO LOCAL AREA COMMUNITY PLANNING GROUP - ARGYLL AND BUTE COUNCIL -GOVERNANCE AND LAW

lain Jackson advised that the intention of this item was to note the progress made in identifying groups and that similar papers had been put to the other 3 LACPGs. The intention was to seek the Group's approval that the groups listed were relevant and that the linkages were correct.

Douglas Hendry suggested that this should be a standing item on the agenda over the next 1 or 2 meetings in order to get to the stage of whether there was comfort or not that these were the right groups. He invited the group to look at these today and commence the feedback procedure.

Participants expressed their concerns that the lists appeared to be out of date and that the same questions were being asked today as had been asked 2 years ago. Councillor Horn stated that the LACPG, in her opinion, was not working. Douglas Hendry agreed that the MAKI LACPG was less developed than the other LACPGs but stated that was for those around the table to seek the right answers and move onwards. He commented that the Group had to crack this issue to establish who were the right people to be involved in community planning at a MAKI level.

The view of the Group was that community planning was best developed in MAKI through the Mid Argyll Partnership and the Kintyre Initiative Working Group, that these groups, together with a group on the Islands represented the basis for community planning in MAKI and that they did not wish to pursue the discussion of proposals framed on a MAKI wide basis at this time. Douglas Hendry advised that this was not a matter for

this Group to determine and that ultimately it would be for the CPP to decide on the structure. He confirmed that the CPP would be considering all the issues raised by the ongoing self evaluation exercise and that the structural issue would require to be addressed further in due course.

12. HIGHLIGHT/EXCEPTION REPORTING - ARGYLL AND BUTE COUNCIL - IMPROVEMENT AND STRATEGIC HR AND GOVERNANCE AND LAW

Given the disposal of the previous item, this item was not discussed.

13. KIWG AND MAP - FUTURE ROLE IN RELATION TO COMMUNITY PLANNING

Given the disposal of item 11 above, this matter was not discussed.




The meeting adjourned at 11.50am and re-convened at 12.40pm when the Chief Executive and Council Leader arrived for the Budget Consultation.

14. BUDGET CONSULTATION




A question and answer session followed the presentation which was recorded by the Council's communications team and would inform the budget process.









Social Affairs Thematic Group Update Report

1. SUMMARY

1.1 This report summarises the continued progress made by the Social Affairs Thematic Group.

2. **RECOMMENDATIONS**

2.1 That the Management Committee note the progress made by the Social Affairs Thematic Group.

3. DETAIL

3.1 At the group's most recent meeting on the 7th November 2011 a number of key issues were discussed and scrutinised including; Community Learning and Development Youth Work, Social Affairs Scorecard and Consultation feedback from the Argyll and Bute Local Development Plan.

In addition, a number of presentations were made, including; Curriculum for Excellence – Lochgilphead Joint Campus, and Provisions of the new Alcohol (Scotland) Act 2010,

- 3.2 A presentation was given which highlighted the budget challenges being faced in the public sector and how these pressures impact on the Third Sector. The presentation highlighted the need for effective partnership working to ensure knowledge and resources are shared effectively to better meet the needs of our communities.
- 3.3 The group were given a presentation on progress made in relation to the implementation of 'Getting It Right For Every Child' (GIRFEC), a key government policy initiative which promotes emphasis on early intervention and improved outcomes for children.
- 3.4 After consideration of the Choose Life strategy which updated the group on Health Improvement across Argyll and Bute, the CPP agreed to give support, in principle, to the forthcoming draft strategies for Health Improvement and Mental Health Improvement. The group also gave a commitment to the 'See Me'

Pledge which aims at eliminating the stigma and discrimination of mental ill-health.

- 3.5 The group were given an update of examination results for 2011 by Chris Shirley, Quality Standards Manager. Comparative data was presented for both national and local comparisons which highlighted that Argyll and Bute is performing relatively well in a national context.
- 3.6 Discussion took place around the new combined Community Plan / Single Outcome Agreement (SOA) 2012-13. The new plan will bridge the year from the end of the current SOA to the end of the current community plan. Although new outcomes have been agreed the CPP Themes will remain the same and many of the success measures already being used for the current thematic scorecards will still be relevant to the new outcomes.
- 3.7 The next meeting of the Social Affairs Thematic CPP group will take place on 13th February 2012 and will feature presentations from Catriona McEntagart from Happy To Translate, on promoting equal opportunities through overcoming language barriers; and Raymond Flanagan (Youth Worker) on the Learning and Development Youth Work service.

4.0 CONCLUSION

4.1 Significant progress has been made over the year in achieving the group's objectives and this progress will continue throughout the following year through the development of strong partnership links and increased scrutiny and development of the Social Affair Thematic Group scorecard.

1. The autumn meeting of the Group viewed an excellent video presentation entitled "Argyll Voices on Climate Change", prepared by members of Lochgilphead Joint Campus. This inspiring short film was part of a Scottish Government sponsored public engagement strategy project, promoted through Young Scot, to investigate Scotland's development as a low carbon economy and the implications for individuals, communities and business. Despite technical difficulties with the presentation equipment, both representatives of the project, gave an enthusiastic and well received presentation that generated a large number of questions. Economy Thematic Group Report Management Committee December 14 2011

argyll and bute communityplanningpartnership

1. SUMMARY

1.1 The last meeting of the Economy Thematic Group took place on 29 November and this report provides a summary of the key issues covered. The group remains focussed on identifying and recording measures which will enable changes in the local economy to be identified and tracked or treated as appropriate.

2. Key Issues

- 2.1 Budget. A presentation on the current budget situation was made by partners, which highlighted the budget challenges being faced by the public sector and how these pressures impact on the third sector. This led to a discussion on the wider economic impacts of the public sector cuts which will be pursued outwith the thematic group meeting.
- 2.2 Scorecard. The Economy Thematic CPP Group scorecard has undergone significant change over the past two years due in part to the agreement to have one scorecard to serve both the CPP Economy Thematic CPP Group and the Council's Economy Policy and Performance Group (PPG). Discussion progressed to the recent Audit Scotland Report into the role of Community Planning Partnerships in Economic Development and the recommendations on having a systematic, evidence based approach and regarding the use of economic indicators in SOA's and economic development strategies.
- **2.3 Bute.** Under Partner Updates, the economic situation on Bute was discussed.

The Dunoon & Bute travel to work area has the highest unemployment in the Highlands and islands at 5% (Nov 2011) and the rate for Bute is estimated at 6.1%. Yet, employers report that they have difficulty in filling vacancies. There is a complex range of economic and social issues for which a wider partnership approach is required.

One in four of the working age population was claiming some form

of state benefit in Oct 2011, 465 individuals were receiving incapacity benefit or employment support allowance. School leaver destination figure suggest that higher than average leavers are leaving the island, and there appears to be a belief that there are few opportunities for young people on the island.

It is difficult to promote inward investment or business expansion when there are recognised difficulties in recruitment.

There is clearly a lot of activity taking place and an alignment amongst the main economic / regeneration partners (public sector, business and community), with a focus on physical regeneration and business growth/social enterprise activity. However, this traditional approach does not seem to be addressing some of the core issues identified on Bute.

The Thematic Group agreed that this matter be raised with the Management Committee to seek agreement and endorsement of a wider partnership approach to address the economic and social challenges on Bute.

Third Sector and Communities CPP Sub-group

1. SUMMARY

1.1 The Third Sector and Communities CPP Sub-group continues to develop its Plan as part of the SOA/Community Plan. Partners are contributing to the Plan with success measures to meet the agreed outcomes.

2. **RECOMMENDATION**

2.1 To note the contents of the report and the progress of the Third Sector and Communities CPP sub-group.

3. DETAIL

- **3.1** The Third Sector and Communities CPP Sub-group met on 11 August, and again on 11 November 2011.
- **3.2** Membership of the Group has regularly been reviewed and comprises Third Sector Partnership, ABSEN, Argyll and Bute Council, NHS Highland, Strathclyde Police, HIE, Strathclyde Fire and Rescue, and, more recently, Argyll College.
- **3.3** The Group has a draft Plan which is now being incorporated into the new draft SOA/Community Plan. The outcomes for the plan were agreed by the group in November. Partners are still inputting success measures, and it is hoped it can be approved at the next meeting in February 2012.
- **3.4** The Group is monitoring the Argyll and Bute Local Services Initiative (ABLSI) project which is providing support and encouragement to the third sector in developing services through co-production. The group has agreed the workplan for the next three months.
- **3.5** The newly approved Third Sector Asset Transfer Pack has been considered by the Group as part of the consultation on the process, application form and guidance.
- **3.6** Future work within the plan includes:

- Development of a Compact
- Creation of a shared Third Sector database
- Monitoring of the new online Better Community Engagement resource pack
- Monitoring of equality and diversity processes

4. CONCLUSION

4.1 The Third Sector and Communities Sub-group continues to evolve and develop. Future work will ensure that third sector and community councils have increased access to information and support and are engaged in the community planning process.
