#### 3. MINUTES

The Minute of Meeting of Helensburgh CHORD Project Board 9 August 2012 was approved as a correct record.

### 4. PROGRESS UPDATE BY MACLAY CIVIL ENGINEERING

### 6. BUDGET POSITION STATEMENT


