# Argyll & Bute ADP Annual Report

## 3.0 Background

ADP Planning and Reporting Guidance aims to support the embedding of outcomes based planning and reporting at local level, helping ADPs to self-assess their performance (including benchmarking against other ADPs) and to articulate their contribution to their local SOA, as well as contributing to a national picture of our overall progress in supporting alcohol and drug prevention, support and treatment. Improved information flows and visibility of ADPs will also help inform national strategies and decision-making by Scottish Government and CoSLA.

The key principles on which this guidance is based are to:

- strengthen local partnership working & joint accountability;
- reinforce outcomes based approaches;
- support ADPs to improve accountability to their CPP and demonstrate their contribution to their local SOAs by building on good practice;
- provide local flexibility but within a national framework to enable benchmarking;
- help build the national picture of delivery;
- minimise additional reporting requirements on ADPs.

It is recognised that the extensive reform of the public sector is likely to have implications for the operation of ADPs - including the review of Community Planning Partnerships and Single Outcome Agreements, the integration of health and social care, the review of Criminal Justice Authorities and the creation of single forces for the Police and Fire services.

1	Design and implement commissioning plan and tender action	G	Commissioning Plan complete. Commissioning process for independent sector providers progressing to timetable, tendering process complete, evaluating period complete. Tender for independent sector addiction services will be awarded on timetabled date of 4th November. Commissioning group will continue to meet to progress the SLA for statutory services in A & B.
2	Establish outcomes based performance framework to monitor service impact	G	We have an agreed local outcomes framework based on the ADP National Outcomes (presented in the ADP Strategy).

- Complete commissioning process for independent sector and award contract and progress the SLA for statutory addiction services - Develop a joint working protocol to include monitoring and evaluation
- Commission Training Needs Analysis to inform Workforce development Plan
- Develop protocols for collaborative working between agencies and all ADP partners
- Develop service user engagement plan to include new and existing addiction service providers
- Collaborate with Integrated Children's services towards better integrated strategic work

## 5.0 Conclusions

Argyll & Bute ADP has delivered on its agreed priorities for 2013-14 and the Ministerial priorities for ADP's. The ADP is going through a period of change having a new chair, a new coordinator and will shortly have a new provider to provide adult addiction services within the independent sector. It continues to work with the National support team for ADP's towards the further development of Argyll & Bute ADP in 2014-15.

Consultations, Previous considerations	All ADP partners are consulted and annual report is discussed and agreed by the ADP Delivery group and submitted to the Executive Group for final agreement and sign off.

Resources	Scottish Government provides earmarked funding to ADPs to help them deliver against agreed outcomes, this funding is routed for administrative purposes via NHS Boards, it is a partnership resource and investment decisions are made on a partnership basis. It is also expected that this resource will be supplemented by investment from partners' core funding and that the Partnership will be responsible for determining how all the available resource is invested. ADP Plans and Reports (2012) demonstrated that additional investment across Scotland was provided from partners' core budgets to support alcohol and drugs interventions. Some ADPs also shared that resources in kind were often provided to supplement the SG funding. ADPs should seek to identify investment from both earmarked and core funds as part of their plans and reports.
	The nature of problem alcohol and drug use means that the total resources used within localities are often greater than those provided to ADPs via the specific allocations from Scottish Government. The ADP aims to map out the total resource utilised in preventing, treating or dealing with the consequences of problem drug and alcohol use in Argyll & Bute and seeks to reflect this in future delivery plans and annual reports. This mapping will go beyond direct expenditure by the ADP to identify, where possible, the cost of problem drug and alcohol use in respect of, for example, criminal justice services, hospital admissions, sexual health and BBV interventions, and child protection services. This mapping will provide a fuller picture of the full costs of problem drug and alcohol use for local partners and will help inform long term strategic planning and service redesign to support early intervention and prevention. Partners are jointly accountable for delivery of the ADP outcomes within this financial framework.
