Prior to the commencement of works on site, the access shall be formed in accordance with the Council's Highway Drawing No. G300, with the bellmouth area surfaced in dense bitumen macadam for a distance of 5m back from the existing carriageway edge and dropped kerbs formed to the satisfaction of the Planning Authority, or as otherwise agreed in writing with the Planning Authority.

Reason: In the interests of road safety.

WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Form the access in accordance with the Council's Highway Drawing no. G300 and surface the 1.) bellmouth areas in dense bitumen macadam for a distance of 5m back from the existing carriageway edge.


