1. THIS IS A FORMAL NOTICE which is served by Argyll and Bute Council, under Section 145 of the Town and Country Planning (Scotland) Act 1997, because it is considered that a condition imposed on the grant of planning permission, relating to the land described below, has not been complied with. It is considered that you should be required to comply or secure compliance with the condition specified in this notice.

#### 2. THE LAND AFFECTED BY THE NOTICE

The site to which this notice relates (shown edged in red on the attached plan) forms an area of land known as **Eat Lodge Poltalloch, Kilmartin, Lochgilphead** 

#### 3. THE RELEVANT PLANNING PERMISSION

The relevant planning permission to which this notice relates is the permission granted by Argyll and Bute Council (Reference Number: 04/00567/DET) on the 27<sup>th</sup> February 2004 for the Erection of extension to dwellinghouse, erection of garage and improvement of existing access

#### 4. BREACH OF CONDITION

The following condition(s) has/have not been complied with:

 Prior to work starting on site, the access hereby permitted shall be formed in accordance with the Council's highway Drawing No. G300 with the bellmouth area surfaced in dense bitumen macadam for a distance of 5 metres back from the exiting carriageway edge and dropped kerbs formed to the satisfaction of the Planning Authority or as otherwise agreed in writing with the Planning Authority..

Reason: In the interests of road safety.

3. Prior to work starting on site visibility splays measuring 2.5 metres by 90 metres measured from the centre line of the proposed access shall be cleared and thereafter maintained clear of all obstructions over one metre in height measured from the nearside metal portion of the adjacent road.

Reason: In the interests of road safety.

#### 5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

- 1.) Form the access in accordance with the Council's Highway Standard Drawing no. SD 08/004 Rev a (as agreed with the Roads Department) and surface the bellmouth areas in dense bitumen macadam for a distance of 5m back from the existing carriageway edge.
- 2.) Clear and maintain visibility splays measuring 2.5 metres by 53 metres in each direction (as agreed with the Roads Department) measured from the centre line proposed access shall be cleared and thereafter maintained clear of all obstructions over one metre in height measured from the nearside metal portion of the adjacent road.

# 6. TIME FOR COMPLIANCE

**Time for compliance: 35 days** from the date the notice takes effect.

# 7. DATE THIS NOTICE TAKES EFFECT

This notice takes effect immediately it is served on you or you receive it by postal delivery.



Failure to comply with this notice may result in the Planning Authority instigating further planning enforcement proceedings such as an Enforcement Notice or a Fixed Penalty Notice.

The 2006 Act amended the 1997 Act to introduce a new planning enforcement power enabling planning authorities to issue a fixed penalty notice (FPN) as an alternative to prosecution where a person fails to comply a breach of condition notice to correct a breach of planning control. Failure to comply with this notice may result a fixed penalty notice being issued, with a fine of £300 in respect of a breach of condition notice. Please note that while payment of this fine prevents future prosecution this does not remove your responsibility to comply with the terms of this notice and may, as a result, instigate the undertaking of further planning enforcement proceedings.
