The following condition has not been complied with:

5 ."Before any work commences on site a new dropped kerb crossing point onto the public road shall be provided and surfaced to a distance 5 metres back from the edge of the prospectively maintainable public road.

Reason: In the interest of road safety".

5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Provide a new drop kerb onto the public road and surface the access 5 metres back.

Time for compliance: 14 weeks from the date the notice takes effect.


