1. THIS IS A FORMAL NOTICE which is served by Argyll and Bute Council, under Section 145 of the Town and Country Planning (Scotland) Act 1997, because it is considered that a condition imposed on the grant of planning permission, relating to the land described below, has not been complied with. It is considered that you should be required to comply or secure compliance with the condition specified in this notice.

2. THE LAND AFFECTED BY THE NOTICE

The site to which this notice relates (shown edged in red on the attached plan) forms an area of land known as FORESTRY ACCESS, LAND OPPOSITE SSE BALLURE SUB STATIONS, TAYINLOAN

3. THE RELEVANT PLANNING PERMISSION

The relevant planning permission to which this notice relates is the permission granted by Argyll and Bute Council (Reference Number: 11/00586/PP) on the 22nd June 2011 for the formation of access point to classified road in connection with timber extraction operation

4. BREACH OF CONDITION

The following condition has not been complied with:

1. Prior to any timber extraction taking place, the access hereby permitted shall be formed in accordance with the Council's Highway Drawings No "SD 08/001 Rev a" with the bellmouth area surfaced to the satisfaction of the Area Roads Engineer and the Planning Authority, as agreed in writing. The proposed access shall have visibility splays of 2.4 metres by 160 metres in each direction formed from the centre line of the proposed access. Prior to work starting on site these visibility splays shall be cleared of all obstructions over 1.05 in height above the level of the adjoining carriageway and thereafter shall be maintained clear of all obstructions over one metre in height to the satisfaction of the Planning Authority.

Reason: In the interests of road safety

5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Form the access and visibility splays as per drawing no. SSD/08/001 Rev a (copy enclosed) including the surfacing of the bellmouth and access area 10 metres back with bitumen macadam and concrete

6. TIME FOR COMPLIANCE

Time for compliance: 28 days from the date the notice takes effect.

7. DATE THIS NOTICE TAKES EFFECT

This notice takes effect immediately it is served on you or you receive it by postal delivery.



The 2006 Act amended the 1997 Act to introduce a new planning enforcement power enabling planning authorities to issue a fixed penalty notice (FPN) as an alternative to prosecution where a person fails to comply a breach of condition notice to correct a breach of planning control. Failure to comply with this notice may result a fixed penalty notice being issued, with a fine of £300 in respect of a breach of condition notice.
