THIS IS A FORMAL NOTICE which is served by Argyll and Bute Council, under Section 145 of the Town and Country Planning (Scotland) Act 1997, because it is considered that a condition imposed on the grant of planning permission, relating to the land described below, has not been complied with. It is considered that you should be required to comply or secure compliance with the condition specified in this notice.

# 2. THE LAND AFFECTED BY THE NOTICE

# 3. THE RELEVANT PLANNING PERMISSION

The relevant planning permission to which this notice relates is the permission granted by Argyll and Bute Council (Reference Number: 10/01834/PP) on the 20<sup>TH</sup> December 2010 for the temporary widening of access and drive

#### 4. BREACH OF CONDITION

The following condition has not been complied with:

3. The proposed access shall be formed in accordance with the Council's Highway Drawing No. SD 08/001 Rev A, and shall have visibility splays of 42 metres in each direction formed from the centre line of the proposed access and set back 2.4m from the existing carriageway. Prior to work starting on site these visibility splays shall be cleared of all obstructions over 1.05m in height above the level of the adjoining carriageway and thereafter shall be maintained clear of all obstructions over 1.05m in height to the satisfaction of the Planning Authority.

Reason: In the interests of road safety.

#### 5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Surface the access 10m back from the roadside carriageway as per the Council's Highway Drawing No. SD 08/001 Rev A

#### 6. TIME FOR COMPLIANCE

**Time for compliance: 28 days** from the date the notice takes effect.


