4. BREACH OF CONDITION

The following condition has not been complied with:

5. Within two months of the completion of the new access hereby approved the existing access point shall be permanently closed off to vehicles by physical means and the verge soiled to the satisfaction of the Council as Planning Authority.

Reason: In the interests of road safety.

5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Erect the agreed screen timber board fence.



The 2006 Act amended the 1997 Act to introduce a new planning enforcement power enabling planning authorities to issue a fixed penalty notice (FPN) as an alternative to prosecution where a person fails to comply a breach of condition notice to correct a breach of planning control.
