4. BREACH OF CONDITION

The following condition has not been complied with:

- 3. Prior to the first use of the access the following works shall be undertaken to the satisfaction of the Planning Authority:
 - *i.* Construction of the access in accordance with the standard detail drawing ref: SD 08/001 rev A.
 - *ii.* Sightlines measuring 75 metres from a 2.40 metre setback at the centre point of the access to be free of all obstructions over 1.05 metres above the new access.
 - *iii.* A turning area for an articulated vehicle to be provided within the application site.

Reason: In the interest of road safety.

3. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Form the access to the Council's Highway Drawing No. SD 08/001 rev A, form the relevant sightlines and provide the requested turning area.

4. TIME FOR COMPLIANCE

Time for compliance: 28 days from the date the notice takes effect.

5. DATE THIS NOTICE TAKES EFFECT

This notice takes effect immediately it is served on you or you receive it by postal delivery.



Failure to comply with this notice may result in the Planning Authority instigating further planning enforcement proceedings such as an Enforcement Notice or a Fixed Penalty Notice.

The 2006 Act amended the 1997 Act to introduce a new planning enforcement power enabling planning authorities to issue a fixed penalty notice (FPN) as an alternative to prosecution where a person fails to comply a breach of condition notice to correct a breach of planning control. Failure to comply with this notice may result a fixed penalty notice being issued, with a fine of £300 in respect of a breach of condition notice.
