## 4. BREACH OF CONDITION

The following condition has not been complied with:

4. Prior to the commencement of works the finishing colours of the storage containers and the timber board fence will be submitted to and agreed in writing by the Planning Authority. The development shall be completed in strict accordance with such details as are approved prior to the use of the site for a builders storage yard and shall be so maintained thereafter in perpetuity.

Reason: In the interests of visual amenity and maintaining the integrity of the conservation area within which the site is located.

#### 5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Erect the agreed screen timber board fence.

Time for compliance: 28 days from the date the notice takes effect.



The 2006 Act amended the 1997 Act to introduce a new planning enforcement power enabling planning authorities to issue a fixed penalty notice (FPN) as an alternative to prosecution where a person fails to comply a breach of condition notice to correct a breach of planning control. Failure to comply with this notice may result a fixed penalty notice being issued, with a fine of £300 in respect of a breach of condition notice.
