The following condition has not been complied with:

Prior to work starting on site, the estate access permitted by virtue of 02/01489/OUT shall be formed in accordance with the Council's Highway Drawing No. G300 with the bellmouth area at the junction with Ardlarach Road surfaced in dense bitumen macadam for a distance of 5 metres back from the existing carriageway edge and with dropped kerbs formed to the satisfaction of the Planning Authority or as otherwise agreed in writing with the Planning Authority.

Reason: In the interest of road safety.

3. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Form the access to the Council's Highway Drawing No. G300 and surface in dense bitumen macadam for a distance 5 metres back from the existing carriageway edge in accordance with condition nos.3.

4. TIME FOR COMPLIANCE

Time for compliance: 35 days from the date the notice takes effect.

5. DATE THIS NOTICE TAKES EFFECT

This notice takes effect immediately it is served on you or you receive it by postal delivery.



The 2006 Act amended the 1997 Act to introduce a new planning enforcement power enabling planning authorities to issue a fixed penalty notice (FPN) as an alternative to prosecution where a person fails to comply a breach of condition notice to correct a breach of planning control. Failure to comply with this notice may result a fixed penalty notice being issued, with a fine of £300 in respect of a breach of condition notice.
