Meeting of Caucus of Cowal and Bute Community Councils in Hill Street Offices, Dunoon on Wednesday 12th February 2014

In attendance: Marian Norris (Ardentinny C.C.), Robert Aldam (Kilmun C.C.), Iain MacNaughton (Sandbank C.C.), Ken Barr (Dunoon C.C.), Eleanor Stevenson (South Cowal C.C.), Danielle Clark (Col. & Glen. C.C.) and by V.C. Grace Strong (Bute C.C.)

As the first meeting of the new caucus, consideration was initially given to deciding on a Convener. Although absent, Max Barr of Dunoon C.C. had previously indicated he would be willing to take on the role if no one else was interested. Max was unanimously appointed.

The purpose of the meeting was to determine appropriate agenda items for the next Community Planning Group meeting on 4th March in Rothesay. After some discussion, the following was agreed:-

• Cowal cycle and transport initiative :-

A & B Council ("the Council") is requested to support the proposal of a cycle route from Ardentinny to Toward which would aim to promote cycling as a recreational activity, encourage more people to cycle rather than drive and serve as a local heritage journey linking up locations such as Ardentinny walled garden, Blairmore pier, Argyll Mausoleum, the proposed nature reserve at the head of the Holy Loch, Lazaretto Point, Castle Hill/Castle House Museum, Castle Toward, etc. Council support is essential and will enable the six community councils concerned to seek funding from bodies such as the Climate Challenge Fund and SUSTRANS.

If the Council is supportive of the project, both it and Police Scotland are requested to identify traffic and highway engineering issues which they consider will need to be addressed, e.g. roadside vehicle parking, road surface conditions, carriageway widths, pinchpoints such as Hunter's Quay ferry terminal, etc. It would be very helpful if this could be done fairly soon.

• Funding application :-

The Council has apparently applied for around £100 million of funding for new development proposals in the Oban area. Given the dire state of the local economies in Dunoon, Rothesay and Campbeltown and the comparative affluence of Oban, what is this for?

• Fly tipping :-

Why is it cheaper for local builders to transport waste construction material by ferry to recycling/disposal centres on the opposite side of the Clyde than to take it to the local facility at Dalinlongart?

• Free parking:-

Why is there free parking around the centre of Gourock but not in Dunoon?

Dog fouling :-

This public health hazard continues to be an issue for all local community councils despite both the Council and Police maintaining they regard it as a "serious" matter. The caucus wishes to make the following recommendations:-

- 1. A penalty of 24 hours community service for all identified offenders.
- 2. All dog walkers to be required to carry plastic bags.
- 3. Implementation of an information campaign highlighting the hazards associated with dog faeces.
- 4. Random checks by Police officers and community wardens when dogs are likely to be walked by their owners, i.e. morning and evening.
- 5. Imposition of automatic fines.

• Public toilets :-

According to the Scottish Tourist Guides Association the first question that bus parties and many other tourists have when they arrive in a town is "Where are the public toilets?". As the economy of Dunoon and its neighbouring communities still relies on tourism what is planned to improve the current dearth of readily convenient public conveniences in both Cowal and Bute? Are there any proposals, for example, to install vandal resistant facilities?

COWAL CYCLE & TRANSPORT INITIATIVE

A collaboration of 6 Community Councils

AIM

By collaboration on 6 community projects provide a level coastal cycleway from Ardentinny to Toward.

FUNDING

- The Initiative was prompted by the Climate Challenge Fund

- With Argyll & Bute Council Support it is hoped to involve SUSTRANS the infrastructure elements of the project

Community Safety Forum Exception reporting to the Local Community Planning group

1. SUMMARY

1.1 The purpose of this Paper is to update the Area Community Planning Group regarding the main pieces of work undertaken by the Area Community Safety Partnerships in the last time period.

2. RECOMMENDATIONS

That the ACPG:

- 2.3 Note that the groups are considering the future direction of Community Safety provision and how best to support it.

3. DETAIL

- 3.1 The Area CSP is a partnership focusing on community safety issues in a broad sense and undertakes various pieces of work in this arena.
- 3.2 There is a move to align all service provision with the outcomes identified in the Single Outcome Agreement, to which all public sector partners are signatories
- 3.3 The Area Community Safety partnerships had an agenda item this round of meetings requesting that they consider the future role of the Forums and what their future would or should be. It was noted that the Chair of the Community Planning Partnership Management Committee, Chief Superintendent Barry McEwan is also leading on the work stream relating to outcome 6 of the Single Outcome Agreement "People live in safer and stronger communities" and that he will be providing a strategic lead and tasking on community safety. The possibility of the remit of the local community safety groups being subsumed within the local Community Planning group was raised.

The potential for a strong strategic lead was welcomed since this could provide necessary focus for the partners efforts, however, the local forums were both seriously concerned that to amalgamate the groups when the CSF is already a subgroup of the Area Community Planning Group, would lead to the loss of focus on local issues and also the loss of local understanding of how issues can be resolved and locally appropriate methods of dealing with problems.

One ground of concern is that the agenda of the full Area Community Planning Groups is very broad. It was noted at both meetings that this was a major issue for members of the local community safety forums to consider, and while more detailed proposals would probably be forthcoming at future meetings, Forum members may wish to consider viable models for the delivery of the Community safety agenda.
