3. DETAIL

- 3.1 The Community Safety Forums are partnerships focusing on community safety issues in a broad sense and undertakes various pieces of work in this arena.
- 3.2 There is a move to align all service provision relating to community safety with the outcomes identified in the Single Outcome Agreement, to which all public sector partners are signatories.
- 3.3 The Community Safety Forums continue to consider what their future will or should be. The possibility of the remit of the local community safety groups being subsumed within the local Community Planning Group has been repeatedly raised by members at both forums, and there is a concern that the new fire and police group may lead to unnecessary duplication where the forums are already a suitable vehicle and could be used for this purpose.

The potential for a strong strategic lead is welcomed since this should provide necessary focus for the partners efforts, however, the local forums are both seriously concerned that to amalgamate the groups when the Community Safety Forums are already subgroups of the Area Community Planning Group, would lead to the loss of focus on local issues and also the loss of local understanding of how issues can be resolved using locally appropriate methods. It is also noted that NHS participation has improved this round of meeting and it is hoped that this will be sustained.

Community Planning Group Area Forum Events

1. SUMMARY

1.1 This report is to inform the area Community Planning Group on the data gathered at the Area Forum events as part of the engagement on the Single Outcome Agreement 2013-23.

2. **RECOMMENDATIONS**

- **2.1** The area Community Planning Group considers how best to utilise the information gathered at the events to ensure feedback is used by partners to inform future planning and activities of the group, including the area Economic Development Action Plan (EDAP).
- **2.2** The area Community Planning Group considers appropriate actions, under each outcome heading, to be taken forward by partners at area level.

3. BACKGROUND

- **3.1** The Area Community Planning Group agreed at its meeting in May to consider a full report on the Area Forum events, which were consulting with communities on the SOA 2013-2023.
- **3.2** It was agreed that the results from the events will feed into the development of the SOA Delivery Plans and a forthcoming Argyll & Bute Population Summit.

4. DETAIL

- **4.1** A total of 14 events were held, including three in Bute and Cowal: Workshops in Rothesay and Dunoon, and a Question Time event in Dunoon with video-conferencing from Rothesay. In addition, a youth event was held to gather views of young people across Argyll and Bute.
- **4.2** A large amount of information was gathered and analysed. A detailed report was produced for and presented to the CPP Management Committee meeting on 25 April 2014. The area CPG requested a more localised report for its June meeting, and this is attached. Within this report are issues raised in Bute and Cowal, alongside potential solutions, which were put forward by participants at workshop events.
- **4.3** Information from the online survey is not included in this area report, but some of the data from this is included in the full report covering

all the engagements methods across Argyll and Bute. <u>http://www.argyll-bute.gov.uk/good-place-live-work-and-play</u>

5. CONCLUSION

5.1 The information gathered from this extensive consultation exercise should be used to inform future delivery of services by partners in the area, and to help alleviate issues of population decline.

SUMMARY

This is a report on the recent consultation by the Community Planning Partnership (CPP) in Argyll and Bute designed to identify priorities at local level and inform the Delivery Plans of the ten-year Single Outcome Agreement (SOA) 2013-23. This consultation was undertaken across Argyll and Bute, however, the focus of this report is on findings within the Bute and Cowal area.

The Argyll and Bute wide report is available online¹

Recent census data demonstrated that the population of Argyll and Bute had declined by 3.4%. Population change within Bute and Cowal is -4.8% with significant local variation. It is recognised that for Argyll and Bute to become more prosperous tackling this population decline and cultivating an environment where the economy can thrive are of the highest importance. Attentive to these themes the CPP has agreed the overarching outcome for the SOA: 'Argyll and Bute's economic success is built on a growing population'.

The consultation was entitled: **Argyll and Bute - A Good Place to Live, Work and Play**?" and comprised an online survey and 15 events across Argyll and Bute, with three held in the Bute and Cowal area.

The findings in Bute and Cowal highlighted the need to focus on employment, housing, land ownership issues, transport links, more support for small business, encouraging growth in high income tourism and developing improved internet and mobile connections.

Suggestions include placing a target on desired population within Bute and Cowal (and the wider Argyll and Bute) and the alignment of services to support this growth, a focus on finding a long term solution to the issues of the A83 and connectivity more generally, enhancing support to small and or emerging businesses and raising the rate of broadband internet roll out across Bute and Cowal

The data from this and the full Argyll and Bute wide report will feed into the strategic Population Summit to be held later this year, to consider ways of addressing the population decline in Argyll and Bute.



BACKGROUND

In August 2012 Argyll and Bute Community Planning Partnership agreed to annual consultations on the Single Outcome Agreement (SOA) to ensure communities had a say in how the Partnership can achieve its outcomes.

The figures from the census of 2011 were published and highlighted Argyll and Bute as the highest area in terms of percentage population decline, and this was seen as the greatest challenge for all community planning partners. The 2011 census shows the population of Argyll and Bute was 88,166 which is a 3.4 percentage drop from 2001 when the figure was 91,306.

Argyll and Bute is one of only four out of 32 local authorities across Scotland that has seen a decline in population.

In August 2013, the first stage of Argyll and Bute's Single Outcome Agreement was approved by the Scottish Government. This included:

Principal outcome:

"Argyll and Bute's economy is based on a growing population"

To achieve the principal outcome a set of supporting long-term outcomes were agreed:

- 1. The economy is diverse and thriving
- 2. We have an infrastructure that supports sustainable growth
- 3. Education, skills and training maximises opportunities for all
- 4. Children and young people have the best possible start
- 5. People live active, healthier and independent lives
- 6. People live in safer and stronger communities

In order to achieve these outcomes, a delivery plan has been developed for each of the six outcomes.

The community consultation was designed to inform the content of delivery plans for each of these outcomes in addition to contributing to setting and achieving localised outcomes.

A parallel online survey was undertaken with over 500 responses across Argyll and Bute, including 148 from Bute and Cowal. The data has not been analysed at a local level but some details can be found in the full Argyll and Bute report.

In addition, a Youth Consultation was undertaken on 23rd and 24th of November 2013 by Argyll and Bute Youth Forum, attended by 50 young people, including 9 from Bute and10 from Cowal.

Argyll and Bute Community Planning Partnership is grateful to Education Scotland for its support in part-funding this consultation process, which in turn will feed into the strategic guidance on Community Learning and Development.

WORKSHOP FINDINGS

Introduction

Many of the Argyll and Bute wide issues were picked up within the Bute and Cowal consultation.

Noteworthy comments include a desire for the SOA to consider a specific target population; to implement programmes to encourage growth; and to consider the impact this may have in planning service provision. For example certain areas could be targeted for growth with local initiatives designed to encourage inbound mobility such as a multi-layered approach to housing, targeted small business support, and developing appropriate infrastructure. It was noted at some workshops that other rural areas in Scotland were experiencing growth (for example Western Isles) in population and a suggestion was to learn from their experiences where appropriate.

A brief description of the main headlines from the Argyll and Bute wide perspective followed by detail on local issues and priorities within the Bute and Cowal consultation follows. Potential solutions to the topics and issues raised are based on participants views and comments put forward at workshop and Question Time events.

Outcome 1 - The economy is diverse and thriving

Argyll and Bute

Four main issues were raised in the Outcome 1 workshops:

- Enabling (small) businesses / start-ups
- Promoting Argyll and Bute
- Housing
- Land ownership

CONCLUSION

The consultation highlighted participants' wish to prioritise developing the economic potential of Argyll and Bute through harnessing the strengths of our rich natural resources and heritage. The main points raised were as follows:

- 1. Support to small and medium enterprises, and the expansion of existing businesses through a range of measures including support at the early stages; and availability of suitable premises.
- 2. Support to businesses that produce local goods to expand their markets further afield.
- 3. Better and more appropriate training to enable people to find employment, including increased number of apprenticeship places.
- 4. Improved ferry services reliability, cost and frequency of services.
- 5. Provision of faster broadband, particularly on the west side of Bute and rural Cowal, and better mobile phone services.
- 6. Health service meets the need of the local and ageing population, taking into consideration the need to travel long distances to get medical attention.
- 7. There was general recognition that young people have to leave the area for further and higher education. Many do not return to the area, so the area must be more attractive to encourage them to return once their education is complete.

Options for practical incentives designed to encourage inbound migration include opening land for development; a multi-faceted approach to delivering new, appropriate housing solutions; and a commitment to paying the living wage across Community Planning Partners. All, or some, of these may begin to address the falling population and build a longer term sustainable and vibrant economy, serving the needs of those who choose to live, work and play in one of Scotland's most impressive, hospitable, and safest areas.

This report also suggests there is scope to develop a local area action plan for the Bute and Cowal Community Planning group in parallel with the high level Single Outcome Agreement delivery plans. Such a move would demonstrate a commitment by partners to ensure the priorities of local communities are both listened to and transformed into meaningful action.
