This report looks at the current work plan of the committee, in light of the progress with the Islands Bill that is currently making its way through the Scottish Parliament, and the need to focus on key strategic priorities to better ensure the deliverability of positive outcomes for our island communities.

#### 5.0 DETAIL

5.1 The needs of our island communities are complex and a significant change in legislation is anticipated with the passing of the Islands Bill later this year. Appendix 1 of this report outlines the main areas of work of the committee as agreed in its August meeting 2017. It was anticipated that the work of the committee would also be determined in part by the ongoing work of the National Islands Group but meetings of this group has been infrequent with little progress made. Consequently, there is a need for the committee to determine its key strategic priorities to focus on until greater certainty id delivered through further work at a national level including the passing of the Islands Bill in the summer. A list of potential topics has been identified in the Appendix 1 and members are asked to prioritise these in order to help deliver clear outcomes for our island communities.

### 6.0 CONCLUSION

6.1 There is a need to prioritise the work of the Argyll Strategic islands Group through the identification of key strategic priorities that impact on our island communities. Appendix 1 identifies potential topics to focus on and the report asks members of the committee to prioritise these to inform the future work of the committee.
