APPOINTMENT OF CHIEF EXECUTIVE

1.0 INTRODUCTION

- 1.1 The Council's current Chief Executive tendered his resignation on 23rd September 2019. A recruitment exercise was undertaken and a high number of quality applications were received. The Appointments Panel of 7 members met on 22nd November to carry out a competitive interview process and take a decision on making an appointment.
- 1.2 Pippa Milne, currently one of the Council's Executive Directors, was duly appointed.

2.0 RECOMMENDATIONS

- 3.1 It is recommended that Council note the appointment of Pippa Milne as the Council's new Chief Executive and congratulate her on her success.

3.0 DETAIL

- 4.1 Following the resignation of the current Chief Executive on 23rd September, the Council embarked on a recruitment process. The Appointments Panel, following a competitive process, appointed Pippa Milne to the post on 22nd November.
- 4.2 Pippa will assume Chief Executive responsibilities from 19th December under existing cover arrangements and will formally assume the post on 6th January 2020. This ensures continuity for the organisation.
