SUPPLEMENTARY REPORT NO. 2

1.0 INTRODUCTION

At the meeting of the Planning, Protective Services and Licensing Committee held on 21st October 2020, Members agreed to hold a virtual pre-determination hearing and virtual site visit in respect of the above application. The hearing has been scheduled for 23rd November 2020.

Since this decision, expressions of support have been received from the following three sources:

These most recent contributions have increased the number of supporters by three and mean that the overall level of representation is now as follows:

Those **objecting** to the proposal – 74

Those **supporting** the proposal – 36

Number of signatories to petition **in favour** of the proposal – 100

2.0 SUMMARY OF POINTS RAISED

The main points raised by the most recent contributors can be summarised as follows:

- As a company, Bute Island Foods won Business Innovator of the Year 2018 and seems to get awards every year. It provides its vegan products to Asda, Sainsbury, Tesco and Spar and it is understood that Marks and Spencer's are also looking forward to selling its products - an invaluable flagship to put Argyll and Bute firmly on the map
- Its success demands that it increases its workforce and, to enable this, it is now
 applying for a new factory. As a major employer, it is felt essential to ensure that the
 company stays on the island and the Council is urged to consider the value of such
 an asset, which is a great way to induce young repopulation in an ageing community
