Right Care Right Time – What do our Communities want from HSCP community teams?	Agreed this should be Amber in view of engagement work being undertaken. More dialogue to be added.
Right Care Right Time – Agree model that assist us to move towards a National Care Service	Agreed this should be Amber. Work paused at National level. Include evidence of what has been completed at local level to support preparation for National Care Service.
Primary Care – contribute to review of sustainable services on the island of Coll.	Should be Green – significant work done on this.
Drug and Alcohol Partnership	Jennifer Dryden confirmed all those marked red should be Amber and she will provide narrative.
