**LSO COMMENTS:** This is an application for a new grant of premises licence to allow on sales (tastings) and off sales of alcohol from the subject premises. The site will be a garage style unit, located amongst 4 other similar units. The primary function of the premises will be the blending, spicing, bottling and labelling of rum for sale by retail to the public. The site will include floor space for a shop where the rum and other merchandise will be sold. There will also be distillery tours and tastings.

### **Layout Plan**

The layout plan depicts the licensed area bounded in red. As this is on sales with an off sales facility, there is no alcohol display area – the whole area within the red boundary will be licensed.

### **Operating Plan**

On & off sales - as the premises are providing tastings on the premises as part of the tour experience, both on and off sales have been recorded on the operating plan.

On sales hours – 1200 to 1800 Monday to Thursday and 1100 to 1900 Thursday to Sunday.  
Off sales hours – 1000 to 2200 daily.

### **Seasonal Variation**

Proposed seasonal variation –

*“Due to the reduction in tourism during winter months reduced hours will be operated from 1<sup>st</sup> n November to 1<sup>st</sup> March each year.”*

Board’s policy statement on seasonal variations –

*‘The Management reserve the right to open the business one hour later than the commencement of licensed core hours or close one hour earlier than termination of core hours on any day of the week during winter months i.e. 1st October to 31st March.’*

Taking into account the seasonal aspect of the business offering and the remote location of the premises, the Board may wish to look favourably on this seasonal variation.

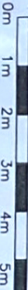
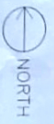

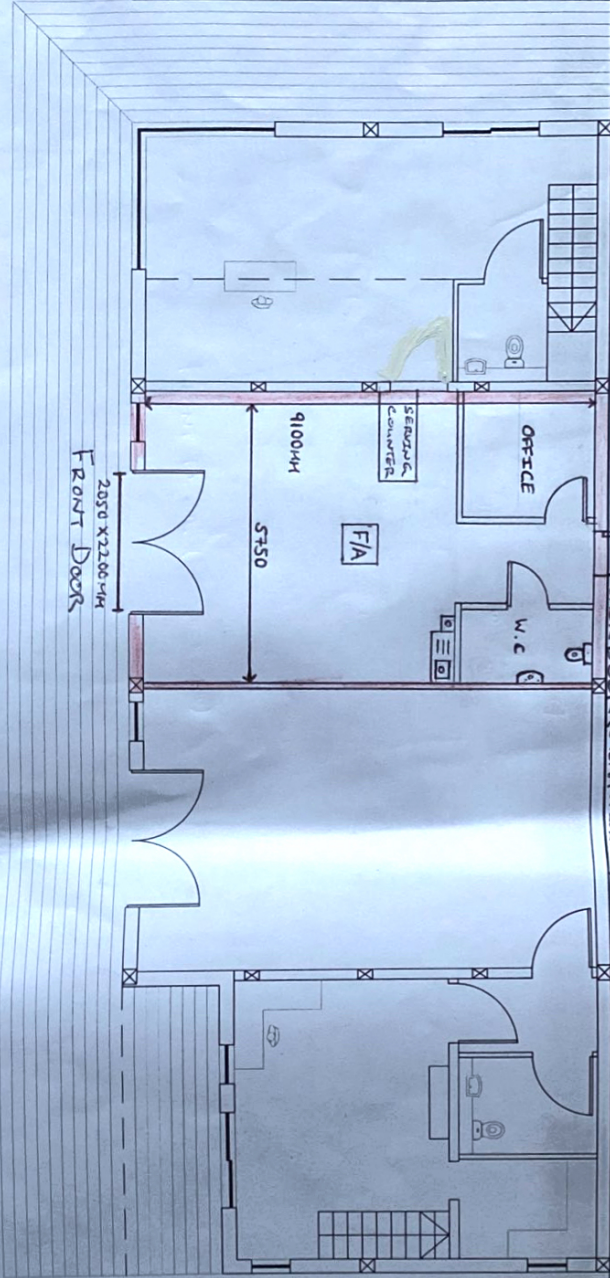

Decking to surround building, extending functionality externally

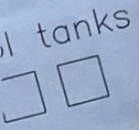

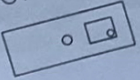

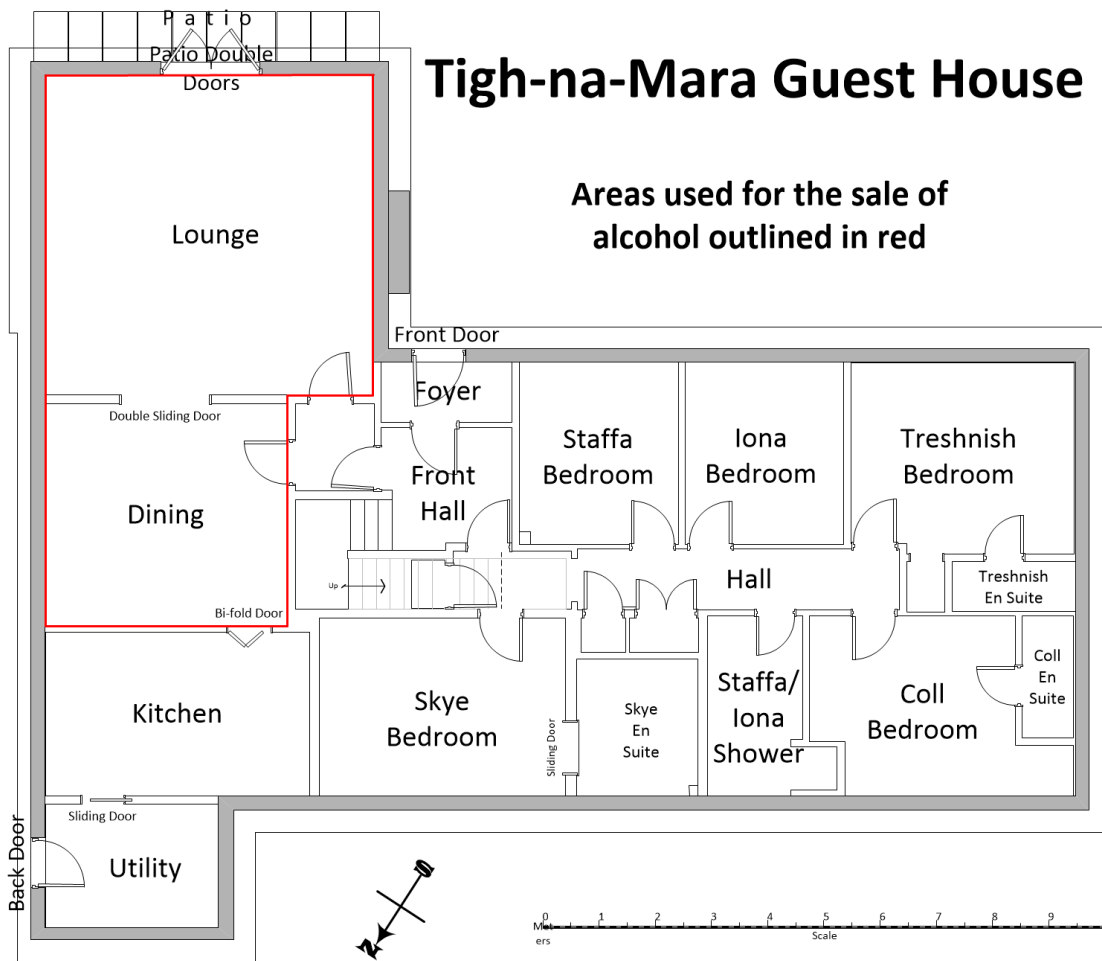

**LSO:** This application is to include the outdoor area indicated in the submitted layout plan (see also photos below) to allow outdoor drinking and the consumption of food. The outdoor area will be situated in the Hotel grounds. The applicant is also requesting takeaway food be added as an allowable activity in the operating plan.

The applicant has been using the outdoor area on a temporary basis under occasional licences and no problems or complaints have arisen.

Location of proposed Outdoor Area

The proposed outdoor area will be located adjacent to the main entrance and accessed via a patio (see photos below). The patio is already licensed for outdoor drinking. The proposed area will be physically delineated with barrels, planters and bunting, making it a distinct area apart from its surroundings.

To ensure social distancing there will be a maximum of 8 tables. However if/when restrictions are to be eased, that may rise to a maximum of 10, varying in seating capacity from 2 persons to 6 persons per table.

The applicant has liaised with neighbours and there are no objections to this application.

Outdoor Curfew

The current curfew hour recorded on the operating plan is 2300. The applicant has advised that she is willing for operate under Board curfew policy of 2200 for persons aged 18 years and over and 2000 for children and young persons. Consequently, the operating plan will need updated at the *Activities Outwith Core licensing Hours box* and the 'Times' box at Children and young person access terms.

Takeaway Food

Takeaway food will be for collection only. There will be no deliveries. The operating plan should be updated at Question 5(f) *Additional Activities* to include takeaway of food.

**Environmental Health Comments for:**

Application for Variation of Premises Licence for Taynuilt Hotel, Taynuilt, Oban.

Observations:

**Public Health and Safety**

1. Concerns are raised on the proximity of the proposed outdoor seating area at the front of the Hotel to the A85 trunk road. The layout provided with the application shows the seating area to be at the side of the trunk road with insufficient protection to safeguard customers from injury should there be a vehicle incident. Please see photograph below of the seating area location to the trunk road. All photograph taken on 20<sup>th</sup> January 2021.



2. Concerns are raised on the proximity of the seating area to the side of the Hotel (described as the beer garden) for vehicles entering and exiting the car park to the Hotel and to private housing located to the rear of the Hotel.

There is the potential for conflict with vehicles and customers/staff when needing to gain access to the Hotel to use the facilities or to provide service of goods as this will require customers/staff to cross the area where vehicles enter and exit the car park. There is also insufficient protection from injury for customer/staff should there be a vehicle incident. Please see photograph below.



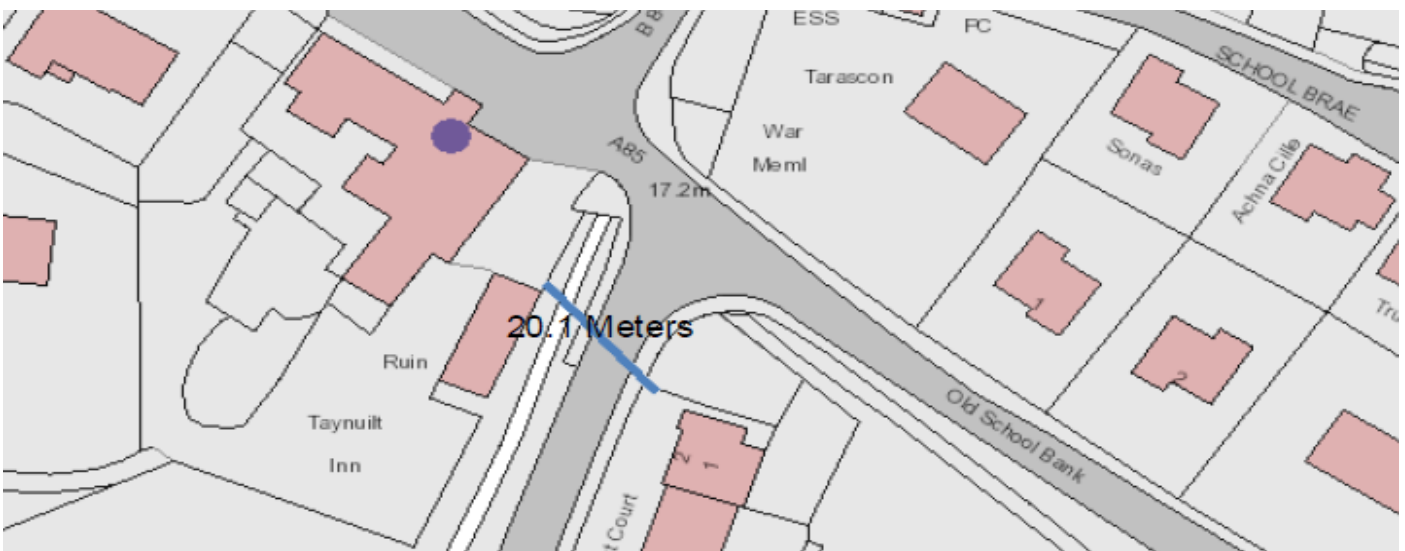


- Concerns are raised for customer safety with the proximity of the beer garden seating area to the open burn. Currently the wall to the side of the burn is only half complete and will need to be completely reinstated and possibly additional railings installed to prevent public gaining access to the burn. Please see photograph below.



### Potential Noise Nuisance

- The location of the beer garden to the nearest noise sensitive receptor is 20 metre as shown in the photograph above and the map below. The proximity of these properties to the beer garden may cause potential noise nuisances issues.

The Board will be aware the applicant has applied to increase the outside drinking area. In relation to the area detailed to the front of the property, the Chief Constable would suggest appropriate delineation would be required along the front of the Hotel between the area and the road to protect the patrons from vehicles travelling along the A85 trunk road.

In relation to the area to the left hand side of the premises, the plan submitted with the application does not seem to be to scale as it appears to indicate more tables and chairs than what would be appropriate for that area. Further, consideration should also be given for safe vehicular access to the car park. Your Honours may wish to confirm with the applicant the procedure for staff and customers accessing the proposed areas safely.

In addition the Chief Constable would suggest that plastic tumblers are used for the outside area due to the proximity of passing vehicles.

However I have been speaking to the applicant and he has advised that there will be a continuous barrier between the beer garden and the trunk road if the application is

looked on favourably. There is also the possibility of a traffic calming effect to having an increased on street presence. Traffic might slow down a bit if there is a bit of activity on or near the road.

In summary then we would prefer it elsewhere but with caveats we would be content with it as proposed.

Good morning Kelly,

I have no issues or concerns with the seating plans to the East of the Taynuilt Hotel. The concerns will be for the proposed seating arrangement to the North of the hotel, immediately adjacent to the A85 Trunk Road.

I note the comments from Neil MacFarlane from the Trunk Road Authority, what I would add is that I would like to see a pedestrian guard rail installed to prevent hotel customers from stepping onto the carriageway.

The area is of reasonable width and is currently or has recently been used as “nose in parking” for the hotel. The width of the proposed seating area would allow room for tables to be located immediately adjacent to the building and still have enough width to the edge of the public road to allow safe customer access and install suitable rails and barriers.

In my opinion, the proposal to change this area to seating would improve road safety (subject to appropriate and suitable rails and barriers being installed to protect customers), due to vehicles no longer reversing on or off the Trunk Road when parking.

The specification for any rails and barriers will be for the Trunk Road Authority to decide on and approve.
