#### MINUTES of MEETING of ARGYLL AND BUTE WINDFARM AND RENEWABLES TRUST held BY MICROSOFT TEAMS on THURSDAY, 22 SEPTEMBER 2022

#### 1. APOLOGIES

The Committee Manager welcomed everyone to the meeting and general introductions were made.

Apologies for absence were intimated on behalf of:-

#### 2. DECLARATIONS OF INTEREST

There were no declarations of interest intimated.

#### 3. MINUTE OF PREVIOUS ANNUAL GENERAL MEETING, HELD ON 9 SEPTEMBER 2021

The Minute of the previous Annual General Meeting of the Argyll and Bute Windfarm and Renewables Trust held on 9 September 2022, was approved as a correct record.

# 4. APPOINTMENT OF CHAIR AND VICE CHAIR OF THE ARGYLL AND BUTE WINDFARM AND RENEWABLES TRUST

Having recognised that the previous Chair, Councillor Anne Horn had stepped down as a Councillor in May 2022, the Trust gave consideration to a report which outlined the recent appointments made by the Council to the Windfarm Trust and invited Members to appoint both a Chair and a Vice Chair.

Councillor Brown confirmed that she was happy to assume the role of Chair.

Margaret Pratt confirmed that she was happy to assume the role of Vice Chair.

With no one being otherwise minded this became the decision of the Trust.

#### Decision

The Argyll and Bute Windfarm and Renewables Trust:

- 1. Appointed Councillor Jan Brown, as a member of the Argyll and Bute Windfarm and Renewables Trust, to carry out the role of Chair of the Trust; and
- 2. Appointed Margaret Pratt, as a member of the Argyll and Bute Windfarm and Renewables Trust, to carry out the role of Vice Chair of the Trust.

#### 5. EAST KINTYRE WINDFARM TRUSTEES

The group gave consideration to the annual report and audited accounts of East Kintyre Windfarm Trust to the year ending 31 March 2022, having heard from Alastair Bennett.

#### Decision

The Argyll and Bute Windfarm and Renewables Trust agreed to note the detail provided.

#### 6. WEST KINTYRE WINDFARM TRUSTEES

The group gave consideration to the annual report and audited accounts of West Kintyre Windfarm Trust to the year ending 31 March 2022, having heard from Margaret Pratt.

Discussion took place around the Council's Shop Local, Love Local campaign, with the Projects and Regeneration Manager advising that she would provide the link to the Committee Manager for circulation around the Windfarm Trust.

#### Decision

The Argyll and Bute Windfarm and Renewables Trust agreed to note the detail provided.

#### 7. INVERARAY WINDFARM TRUSTEES

The group gave consideration to the annual report and audited accounts of Inveraray Windfarm Trust to the year ending 31 March 2022. Consideration was also given to the Community Action Plan.

#### Decision

The Argyll and Bute Windfarm and Renewables Trust agreed to note the detail provided.

#### 8. ALIENERGY

Consideration was given to a report by ALlenergy outlining the background of the sustainable energy charity, together with an overview of current projects and activities.

Discussion was had in relation to the production of renewable energy in the Kintyre area, with members of the Trust expressing concern that this is not offset against the rising cost of energy. Alastair Bennett agreed to forward links to both Councillors Brown and McFadzean which would give detail on the work being undertaken around this, including information on the petition to the Scottish Government to seek a solution based on the output of renewable energy.

#### Decision

The Argyll and Bute Windfarm and Renewables Trust agreed to note the information provided.

#### 9. SSE RENEWABLES UPDATE 2021/22

In the absence of Craig Mullen, the Trust gave consideration to an update which highlighted the SSE Renewables Community Investment Review 2021/22. The review highlighted that SSE Renewables had donated over £9.6 million in community projects in Great Britain and Ireland in the last year.

#### Decision

The Argyll and Bute Windfarm and Renewables Trust agreed to note the information provided.

#### **10. UPDATED WINDFARM TRUST CRITERIA**

At the previous Annual General Meeting of the Argyll and Bute Windfarm and Renewables Trust, it was agreed that the Committee Manager would take forward the updating of the Windfarm Trust Criteria, which was considered to be restrictive and outdated. Consideration was given to the proposed changes to the criteria.

#### Decision

The Argyll and Bute Windfarm and Renewables Trust agreed that the Windfarm Trust Criteria be updated as outlined and instructed the Committee Manager to forward to the Council's Legal Services to ask them to update the Trust Deed.

#### 11. ANY OTHER COMPETENT BUSINESS

Siobhan Jarvie of ScottishPower Renewables provided a brief update on local site activity within the area, including the progress of the Earraghail hybrid project and Sheirdrim development. Siobhan confirmed that ScottishPower Renewables had been successful

in winning the rights to develop an off-shore windfarm off of the West Coast of Islay, and advised that this development would be known as Machair Wind. She further advised that ScottishPower Renewables have paid £2.7m in community benefit across the sites they have in Argyll to date.

#### East Kintyre Windfarm Trust Annual Report 2023

East Kintyre Community Council (EKCC) currently consists of 5 elected members. These members, along with 3 independent trustees, make up East Kintyre Windfarm Trust.

During the financial year ending 31 March 2023, EKWFT received £61,918 in grant payments from Argyll & Bute Council in relation to Beinn an Tuirc 1 and 2 and Deucheran Hill Windfarms.

A total of 13 applications for grant funding were received during the year with 12 being approved and 1 refused. Grants totalling  $\pounds$ 44,415 were agreed, although only  $\pounds$ 30,215 was paid out during this period. This remains less than half the pre-pandemic level and, while this may partly be due to clubs and groups only slowly becoming active again, the opening of the East Kintyre Community Fund has undoubtedly had an impact. This fund received 18 applications during the year and agreed grants of over £125,000.

The decrease in grant payments compared with the previous year is also explained by a significant grant of £25,000 being included in the 2021/22 figures. This grant helped Carradale Community Trust establish the Carradale Community Shop and Post Office, which now employs one full time manager and 2 part-time Post Office Assistants. A group of about 20 volunteers also help staff the checkout and stock the shelves. The shop is now recognised by HMRC as filling a primary CCT charitable purpose, meaning it is exempt from tax and can apply for grants to help with running costs. It has been a huge success and become the hub of the community, and is greatly appreciated by both residents and visitors who can now save themselves a 30 mile return journey to the shops in Campbeltown.

Carradale Golf Club, which is registered as a Community Amateur Sports Club, received grants of £12,071 towards the purchase of replacement grass cutting equipment. This machinery is also available for the maintenance of a significant area of playing fields owned by the community council. Indeed, the maintenance of a network of tracks and paths in the Carradale area is a priority for the community. Walking and outdoor recreation were identified in the East Kintyre Local Development Plan (LDP) 2020/25 ( <a href="http://eastkintyre.org/ldp.php">http://eastkintyre.org/ldp.php</a>) as priorities by both residents and visitors. To help with this, EKWFT sets an annual budget for the maintenance of paths and community areas and facilities. in the last year £3876 was paid out to local contractors to carry out these works. A grant was also made to The Kintyre Way to assist with the maintenance and promotion of the East Kintyre section of the route.

A grant of £3,000 was made to Carradale Parent Council to help them develop an outdoor learning space at Carradale Primary School. This will consist of an outdoor pod and polytunnel and will benefit the whole community through extra-curricular gardening clubs that will support the school vision of encouraging healthy eating.

Village halls remain a priority for the community and grants totalling £8,412 were made to Carradale Village Hall for the purchase and installation of a new heating boiler and towards the annual insurance premium. Use of the hall is increasing again, including by a group for the elderly run by Shopper-Aide, which was given a grant of £800 towards their expenses. Heritage is seen as a key element in providing a sustainable, resilient and connected future for East Kintyre in it's LDP. To assist with this, grants were made to Carradale Community Trust for the purchase of a display cabinet for the Heritage Centre at the Network Centre and to Saddell Abbey Trust for the installation of new posts and chains around the car park at Saddell Abbey.

EKWFT will continue to support larger projects such as the Community Shop and Post Office, which are more likely to deliver long term benefits to the community, in line with the East Kintyre LDP. To assist in this regard, a development fund was established in 2016 and currently has a balance of  $\pounds$ 65,360.

Each year, 10% of all community benefit funds received are transferred into a retention fund (2 bank term deposit accounts) for use by future generations. At 31 March 2023 it had a balance of £76,282.

Wherever possible, trustees look for evidence of match funding from applicants, although a degree of flexibility is often necessary as it becomes increasingly difficult for them to obtain such funding.

## West Kintyre Community Council Windfarm Trust Annual Report April 1<sup>st</sup>, 2022 – March 31<sup>st</sup> 2023

This annual report for the AGM of the Umbrella Trust covers the period of April 1<sup>st</sup> 2022 to March 31<sup>st</sup> 2023 and is the first report covering a fully operational year for those groups receiving funding help since all restrictions concerning activities during the years of the pandemic were lifted. However, Community Halls and groups were initially cautious with regards to becoming fully operational but do now appear to be operating normally.

During the period covered by this report we received a total income of  $\pounds 66,487.24$  which is broken down as follows: -

- two payments from Beinn an Tuirc of £30,576.13 and £20,687.03 which includes the late second payment due from 2021-22
- £10655.18 from Deucheran,
- £1,500.00 from Tangy 1
- £3.068.90 from Scottish and Southern Tangy 2

As shown on the audited accounts accompanying this report grants of  $\pounds 47,277.12$  have been paid out during this period, plus  $\pounds 200.72$  expenses which were for the cost of the newspaper adverts. However, a further  $\pounds 26.000.00$  was granted to Clachan village Hall towards the costs of the development of the new hall but to date  $\pounds 25,643.41$  of this grant is yet to be claimed due to the workload of the specialist workers to undertake the work due to it being a listed building. We have therefore given them an extension of time to submit invoices to us for this outstanding sum.

Grants allocated were again wide and varied as shown in the accounts and include funding for such things as funding towards the Kintyre Way, Marie Semple Local cancer care fund, ploughing matches, swimming lessons for primary age children and an outdoor centre in the grounds of Clachan Primary School which is open for the whole community to use throughout the year outside of school hours.

This years education project saw our primary school children learn about food production from source to table and included children visiting local producers such as farms and a local dairy to and cheese factory to name a few plus they grew their own vegetables in the school garden and learnt how to prepare and cook them. This programme proved highly successful with the pupils soon understanding that not all foodstuffs start life in a freezer or need to go in a microwave to cook plus by buying and producing locally less delivery miles are needed which helps towards the reduction of our carbon footprint.

I reported last year that we had at last been able to set up a project team to progress the long term "legacy" project of the installation of toilets and showers at Westport Beach. However, after 18 months of hard work by the project team which included agreement by all parties on the final design and finishes, sadly, the landowner withdrew his offer of a " peppercorn" or indeed any lease for the land required for the facility even though we had agreed at his request to include permission for a tent only campsite to be developed and run by the landowner in our planning application. Therefore, the 70k set aside for this project is not currently required.

We continue to manage the toilets at Tayinloan ferry terminal which we took over the running of some years ago from the Council to avoid their closure. However, these are now getting so old they are becoming difficult to keep clean and hygienic plus do not have any facilities for babies or those with a disability. We have now lodged a community asset transfer request to the Council with a view to buying the building outright demolishing it and rebuilding a modern facility that will be easier to maintain and a long term asset to the not only the community but to the many who visit the area and our wonderful beaches. Therefore, the 70k set aside for Westport will now be reserved for this project. We continue to hope that some time in the future the landowner at Westport can be persuaded to change his mind and thus allow us to re-visit that project.

We are also currently considering lodging a Community Asset Transfer request to the Council for the car park at Tayinloan to develop the area further for the benefit of all users.

Finally, it is good to see to applications coming forward since the pandemic and the ability we now have to start work in earnest in developing the projects contained within the local community development plan drawn up in consultation with the whole community.

# Agenda Item 7

## **ALIenergy Overview 2023**



Argyll, Lomond and the Islands Energy Agency (ALlenergy) is a sustainable energy charity based in Argyll and Bute, Scotland. ALlenergy currently has a team of 16 working on a range of projects in Affordable Warmth/Alleviation of Fuel Poverty; Education and Skills Development; and Local Energy.

ALlenergy's aims are:

- To help people with fuel poverty and energy efficiency issues
- To encourage community renewables and local energy economy
- To reduce carbon emissions and mitigate climate change.

Affordable Warmth Advice Service – over the past year, funders have included Energy Redress Scheme, Robertson Trust, Argyll & Bute Council, Highland Council, Bank of Scotland, Smart Energy GB, Big Energy Saving Network, Scottish Federation of Housing Associations, Energy Action Scotland / William Grant Foundation, Scottish Government's Investing in Communities Fund, Argyll & Bute Community Led Local Development Fund, SSE Renewables (Tangy), various donations.

In response to the energy price crisis and the increasing number of households struggling to afford to adequately heat their homes, we have further expanded our affordable warmth activities.

Our service offers a range of energy advice topics to raise awareness, increase resilience and reduce the risk of fuel poverty going forwards, alongside crisis interventions, referrals for insulation and heating replacement schemes, support with complex issues and dealing with energy companies and the ombudsman. We offer a mix of home visits, face-to-face advice at events and telephone sessions. We also deliver free training events, for frontline workers that support vulnerable or disadvantaged people, to help them to recognise and refer fuel-poor households. This is an extremely effective way for us to engage with hard-to-reach individuals who may otherwise be reluctant to ask for help for a variety of reasons. We also receive a large number of direct enquiries.

Our clients are typically vulnerable to fuel poverty for reasons such as low income, poor health/disability, and reliance on high-cost heating. Many have no access to gas, often using electric storage heaters on expensive electric tariffs. Many are self-restricting or in debt to suppliers.

We have continued to access crisis payments for clients from various sources. These include: prepayment meter vouchers and bulk fuel deliveries from the Fuel Bank Foundation; energy debt relief and ongoing cost payments from the Scottish Government Home Heating Support Fund; free appliances (cookers fridges, freezers, washing machines) from the Glasspool Trust; and we are a partner in the Argyll & Bute Flexible Food Fund which provides cash interventions alongside money advice (from Bute Advice Centre) and energy advice from ourselves. We continue to prioritise urgent cases, and aim to provide rapid financial assistance and crisis interventions wherever needed – alongside providing the advice and referrals to address longer term resilience to fuel poverty.

Among all the factors which make fuel poverty so serious here, particularly crucial is the lack of access to mains gas across much of the area. Electric heating can be 3-4 times as expensive per kWh than gas. We also have cold wet weather, energy inefficient housing, elderly demographics, and typically low average incomes. Detailed recent statistics are not yet available, but fuel poverty is now thought to affect over 50% (the majority) of households across northwest Scotland.

Our advisors were overwhelmed with clients last winter and are likely to be again as soon as the weather cools down, after a slight easing in client numbers over the summer months. We endeavour

to offer advice and assistance to any individual who is struggling to pay their energy bills. In very busy periods, there may be waiting times and we aim to prioritise the most needful clients.

#### Community Energy for Energy Solidarity (CEES), funded by Horizon 2020.

Working with 10 partners from Portugal, France, Belgium, Croatia and UK, this 3-year European project identifies, compares and analyses successful community energy initiatives to tackle fuel poverty in different countries, and creates a toolkit for replication. Through investigating different funding methods for tackling energy poverty, the project may also help us to diversify our own funding methods. We continue to promote and disseminate our good practice activities and achievements across the network and learn from others; and feed data into a formal evaluation exercise of partners' good practices led by our academic partner, the University of Birmingham.

**Consumer Comfort Choice** (funded by Scottish Government CARES, and Centrica's Energy for Tomorrow grant: Across much of rural Scotland, mains gas is unavailable, and many households use electric storage heaters, which can be difficult to control and expensive to run – contributing to the issue of fuel poverty. Charging may be controlled via smart control technology, providing greater comfort and control, less energy waste and reduced costs. Working with technical partner Connected Response, we seek to install smart controls in 90-100 households with storage heaters in Oban and monitor the resulting improvements in energy bills and household comfort. This innovative project has recently restarted after a pause due to issues with the energy price crisis which delayed the roll out of smart meters and prevented people from switching suppliers.

#### ALlenergy's Education and Skills Development Programme

Funded by Scottish Power Renewables, Beinn an Tuirc Community Benefit Fund 'Regional Tranche'. This local economic development project encourages and facilitates young people to pursue local careers in STEM subjects and the renewable energy sector, providing events, workshops and careers advice in schools and communities, particularly in the areas of Mid Argyll and Kintyre.

The project makes first contact with young people during their transition from P7 to S1, with activity stands at events followed by energy and climate change-related classroom workshops, and careers activities delivered in the three secondary schools in Campbeltown, Tarbert and Lochgilphead. In the summer, each year, the ALIenergy education officers also run stands for the whole community at the main Agricultural Shows in the area: Kintyre, Mid Argyll and Islay.

In recent years, ALlenergy has created a series of three short films in 2021, 2022 and 2023 showcasing the diversity of careers opportunities in STEM related local businesses. The first, 'STEM Journeys in Argyll' showcased four STEM professionals working in the Argyll & Bute area, highlighting the range career paths open to young people as well as raising awareness of the opportunities for STEM roles in the area. The 2022 film 'A Day in Industry 2022' followed a selection of pupils' work experience group placements organised by ALlenergy in local STEM-related workplaces. S4-6 applicants put into practice a range of employability skills in a bid to spend hands-on time in the workplace, finding out at first-hand what the company does and how STEM skills are integrated into the work of its staff. Building on these, 'A Day in Industry 2023' filmed 10 successful applicants from school years S4-6 in individual work experience placements with 7 local STEM employers: Ardern Yacht Centre, Argyll Pharmacy, DM Fabrications, Forestry and Land Scotland, Kintyre Gin, Midton Acrylics, Renewable Parts). Going forward, education officers are now focussing on organising a major local careers event, MAKSTEMFest in early 2024. This follows preparatory work and planning carried out for a previous event which was due to take place in spring 2020, which sadly had to be cancelled at the last minute due to the pandemic. Education Officers are delighted and excited to now be returning to this.
