# 3. MINUTES OF MEETING OF 4TH SEPTEMBER 2012

The Minutes of the Meeting of 4<sup>th</sup> September 2012 were approved as a correct record.

# 4. ARGYLL COMMUNITY HOUSING ASSOCIATION UPDATE

Members heard from Alistair MacGregor on the investment programme in Bute and Cowal for 2011/12 and the projected investment for 2012/13. The ongoing initiatives ACHA will be taking forward including affordable housing in Ardenslate, the purchase of property for ACHA's office in Rothesay, and roof and roughcast work being completed. Alistair also spoke on the Welfare Rights Services and the new "Bedroom Tax" and how it would affect tenants. He further advised that from April 2013 ACHA will provide in house maintenance services across Argyll and Bute and will employ 44 people and have an initial turnover of £3.2m.

# 2. ARGYLL & BUTE COUNCIL BUDGET CONSULTATION

The Group heard from the Executive Director of Community Services on the budget consultation for Argyll and Bute Council. The Executive Director advised that this was a long term approach with £40m to be saved over 7 years. The Executive Director explained where the Council's budget was spent and gave an in depth view of each departments budget.

The Group asked questions on the NPDO expenditure, the shift between NHS and Social Services, ring fenced services, sharing services with other Councils, what services the Council should be providing and if these can be changed e.g. fortnightly bin collections, increase in charges and how the Council charge for their services, staff redundancies, the use of IT to cut down travel etc., items that could not be reduced eg, loans and information provision.

## Decision

The Group noted the information provided and agreed that the ppoints raised will be fed into the Budget Process.

# 3. COMMUNITY PLAN CONSULTATION

The Group heard from the IOD Project Officer on the Argyll and Bute Community Planning Partnership Strategic Needs Assessment.

She advised that the Community Planning Partnership had asked Partners for feedback and spoke on the issues that had been raised. She further spoke on the 16 National Outcomes set by the Scottish Government and the six key priorities. She asked the Group to think about how Housing, Education, Children older than age 5 and the Environment could be accounted for in the Single Outcome Agreement. The IOD Project Officer advised that he draft outcomes would be considered by the Full Partnership in March and then submitted to the Scottish Government.

# The future of the Destination Dunoon and Cowal Steering Group

#### 1.0 SUMMARY

1.1 The Destination Dunoon and Cowal Steering Group was set up in 2007 as a result of a report commissioned by 3 lead partners Argyll and Bute Council, Highlands and Islands Enterprise and Loch Lomond and the Trossachs National Park which identified the action needed to address the economic challenges in the Dunoon and Cowal area.

The report was known as the Dunoon Framework. The executive summary of the report set out a number of key actions and a wider partnership group was formed to address these. A summary of the original key actions from the Framework and the responsible partners is set out in Appendix 1. Some actions have been achieved but most are ongoing.

The role of the Steering Group was to monitor progress at a strategic level and communicate results to a wider audience. Much has been achieved during the life of the Group but there is now a need to find a new way forward to reflect changing circumstances.

## 2.0 **RECOMMENDATIONS**

2.1 It is recommended that the Steering Group holds no further meetings and responsibility for monitoring the delivery of the report's recommendations passes to the Area Community Planning Group (ACPG) Partner commitments would remain unchanged and progress would be reported regularly to the ACPG

## 3.0 DETAIL

3.1 There have been a number of very positive developments in the Dunoon and Cowal area in recent months with the BIDS team pulling together their funding application and the Argyll and the Islands Strategic Tourism Partnership becoming a functioning umbrella organisation for the various marketing groups across Argyll. The CHORD project is well underway and is addressing the regeneration of the waterfront area in the town.

The BIDS group are now using the strap line Destination Dunoon and the local marketing groups are developing their own projects and identities. There is a real danger of confusion over how all the various groups fit together and a likely duplication of effort if the Destination Dunoon and Cowal Steering Group continues to operate as it has always done.

It had always been the intention of the Steering Group to form closer links with the Community Planning process as the Area Community Planning Groups became established and this would seem an appropriate time to make this move.

# 4.0 CONCLUSION

4.1 The issues identified in the original Framework Report in 2007 still need to be addressed and the Steering Group recognised that if it ceased to function without completing its work or transferring responsibility for delivery to another community based group it would undoubtedly be reinvented at some time in the future to complete the tasks.

Dunoon and Cowal's position as the Marine Gateway to The National Park is still not fully recognised and the potential benefits this could bring to the local economy can most appropriately be exploited under the direction of the Area Community Planning Group.

# 1. SUMMARY

**1.1** This report asks Bute and Cowal Community Planning Group to consider the decision made in September 2012 to hold an Area Forum event, and to finalise the group's intentions with regard to the event.

# 2. **RECOMMENDATIONS**

- **2.1** That the B & C Community Planning Group:
  - consider what the purpose and outcomes of this event should be
  - feed back to the Management Committee potential planning and resource requirements based on the questions in 3.3.

# 3. BACKGROUND

- **3.1** In August 2012 the CPP Management Committee agreed to hold an annual area forum in each area which would be similar to the Forward Together events and held in November, and further agreed to support the planning and delivery of annual area forum events commencing in November 2013.
- **3.2** The Bute and Cowal Community Planning Group discussed this matter in September 2012, and agreed to the principle of holding an area forum, but were unclear what the purpose and outcomes of the event should be. Members of the group at that time agreed to feed back ideas and proposals on the event to the Area Governance Manager for coordination and progression, but to date no feedback has been received.
- **3.3** For such events are to go ahead successfully planning and resource allocation will require to be undertaken very soon, and for that reason Area Community Planning groups are asked to

consider the following questions.

- 1. What would the format of the events be?
- 2. What would be the length of the event? i.e half day, whole day, two days
- 3. How would remote and/or island communities be involved? i.e. VC, teleconference., remote facilitators, overnight accommodation provided.
- 4. Would the events be an opportunity to highlight good practice or showcase community projects, and if so, from your area, or from other areas in order to share good practice?
- 5. Can you suggest appropriate topics for discussion?
- 6. Would Area Community Planning Groups like to use these events to consult on any issues/plans/etc?

# 4. CONCLUSION

4.1 If area events are to take place consideration of the purpose and possible outcomes must begin well in advance and it is therefore imperative that Area Community Planning Groups identify now what the aims and expectations of their local events will be. A paper outlining the planning and resource requirement will be submitted to the April Management Committee where partners will be asked to commit resources and approve the formation of a short life working group to begin to plan the events.

# Agenda Item 9

# **Report to the Bute and Cowal Community Planning Group**

**1.0** The purpose of this report is to clarify the role of Unpaid Work, identify its current structure in Bute and Cowal and illustrate the types of work being undertaken by squads of offenders in the local community.

#### 2.0 Background

- 2.1 The introduction of Community Payback Orders (which replaced Community Service and Probation Orders) in February 2011 has resulted in a slight increase in offenders receiving Unpaid Work as either a sentence in its own right or as part of a more complex sentence run in conjunction with other requirements.
- 2.2 Unpaid Work Requirements can be imposed by the Court on 2 levels

Level 1 - between 20 and 100 hours to be completed in 3 months

Level 2 – between 101 and 300 hours to be completed within a maximum of 6 months (although the court may stipulate a different period of time).


- 2.3 As with its predecessor Community Service, Unpaid Work must
  - benefit the local community;
  - be aimed at not-for-profit organisations and charities;
  - not take away paid work from others; and
  - costs of materials must be supplied by the beneficiary

#### 3.0 Current Structure

- **3.1** At the end of March 2012 the Criminal Justice Management Team completed an exercise to restructure Unpaid Work across Argyll and Bute and two Unpaid Work Officers (along with a pool of sessional supervisors) were recruited to post.
- **3.2** At present our two Unpaid Work officers are situated in Lochgilphead (Covering Oban, Lochgilphead and Campbeltown) and Dunoon (covering Cowal and Bute).







the role of the new unpaid work officer is quite complex and involves holding cases, working squads, enforcing orders for non-compliance and developing relationships with community agencies. The role of the sessional workers is to support the officers by taking out squads of offenders to carry out their hours. The Unpaid Work Office has no line management responsibility to the Sessional Worker.

#### 4.0 Bute and Cowal - Squads

- **4.1** Since our restructure in March 2012 Bute and Cowal have operated 5 work squads each week, 3 in Dunoon and 2 on Bute. In recent months however, due to an increased need in the area we have added to our Dunoon capacity to include a Friday work squad.
- **4.2** We operate on the basis of a maximum of 1 supervisor to 5 individuals on squad at any given time. Each offender on an Unpaid Work requirement works for approximately 7 hours in a day undertaking a variety of tasks detailed below.
- **4.3** In essence therefore in any one week we have 30 offenders working and 210 hours per week of work being completed. Of course these figures can fluctuate and are dependent on factors such as the weather, compliance of the squad members and availability of sessional staff.
- **4.4** Whilst it is not the intention of Unpaid work to undertake tasks that should be completed by paid workers it is interesting to note that if our squads work to capacity and were paid employees on the average minimum wage (approximately £5.50 per hour as we work with individuals who are aged 16+) they would have contributed approximately £1155 worth of labour to the local communities each week.

#### 5.0 Bute and Cowal – Agency placements

**5.1** On occasion and if the offenders risk permits, an individual may be placed within an agency setting and supervised by that agency directly. This is an area of our work that we continue

to try to develop but at present have had reasonable success in placing offenders in Charity Shops, Residential Homes for the elderly, Local charities such as the Help project and Local community Trusts. We are currently developing links with the Kilfinan Community Trust, Ardentinny Walled Garden and Women's Aid. Such placements enable us to offer a better quality of placement to some of our offenders who match the criteria, giving them more opportunity to complete their hours whilst gaining experience of the work place.

#### 6.0 Types of Work Undertaken by Unpaid Work squads Bute and Cowal

- Beach Cleaning Throughout the area including Toward, Dunoon, Loch Eck, Tighnabruaich, Strachur, Kilmun, Blairmore and Ardentinny
- Gardening Working with ACHA and Fyne Homes we identify vulnerable residents and on a rota basis undertake domestic gardening. We also clear weeds from foot paths road edges. Examples of this included the clearance of weeds from the footpaths at Blairmore and the strimming of road side grass in Kames and Tighnabruaich
- Furniture removal for vulnerable persons only. Each case is assessed on its own merits.
- Path Clearance Bishops Fairy Glen and other woodland areas.
- Winter weather support gritting pathways. Supporting the elderly and vulnerable in their homes. Some winter snow clearance.
- Decorating Examples of work undertaken include the painting of Dunoon stadium railings, Tighnabruaich waterfront railings and various village halls such as Strachur and Lochgoilhead.
- Woodwork and Joinery The creation of raised beds, school play equipment and historically even the design and building of doll's houses for the local hospice.
- Litter picking throughout the region.
- **6.1** This list is not exhaustive and we are always on the lookout for new ideas and projects. We would welcome any suggestions from the Community Councils and look forward to forging strong links in the future.
