1. APOLOGIES

The Chair welcomed everyone to the meeting.

Apologies were intimated from Councillor McAlpine.

2. DECLARATIONS OF INTEREST

Councillor Horn declared a non-financial interest in item 10 of the agenda (Third Sector Grants 2015/16), as a Committee Member of Tarbert After School Care. Councillor Philand declared a non-financial interest at item 10 of the agenda (Third Sector Grants 2015/16) as a Member of the Dochas Board. Councillor Taylor declared a non-financial interest in item 10 of the agenda (Third Sector Grants 2015/16), by virtue of being involved with Kilmartin Museum.

3. MINUTE OF THE MID ARGYLL, KINTYRE AND THE ISLANDS AREA COMMITTEE - 4 FEBRUARY 2015

The Minute of the previous meeting, held on 4 February 2015 was approved as a true record.

Page 2

Matters Arising:-

Councillor Kelly enquired as to the position of the sunken graves in cemeteries following on from previous discussions. The Amenity Services Manager advised that he would take the issue up locally and report back to Members in due course.

In regards to the issue of the re-erection of headstones, the Chair confirmed that a report was going before the next meeting of the Environment, Development and Infrastructure Committee.

Councillor Kelly requested an update in regard to the funding of the Kintyre Way. Councillor Colville confirmed that at present the Council were awaiting receipt of the Business Plan from Kintyre Way, prior to any decision being taken.

Councillor Kelly enquired as to whether the report from the Scottish Flood Forum, in respect of providing flood gates in the Perth and Kinross area had been circulated to Members. The Area Committee Manager confirmed that it had been, and advised that she would re-send it to Councillor Kelly.

4. PUBLIC AND COUNCILLORS QUESTION TIME

There were no questions submitted.

5. RENAL DIALYSIS AND OBSTETRIC SCANNING SERVICES

The Committee considered a report outlining the pilot for a Hub and Spoke model of Dialysis within the CHP for the Argyll and Bute area, which is to begin in Summer 2015 and is to be evaluated after one year. The report outlined the timescales involved in the project, the location of the unit and nurse training. Members noted that the purpose of the pilot was to ascertain whether this service can be established, sustained and supported remotely by the specialist renal team from NHS Greater Glasgow and Clyde to ensure a high quality and safe local community dialysis service. Members further noted the work which had been undertaken over the last year to explore options for delivering expanded scanning services for women during pregnancy. Discussion took place in relation to the additional funding which is to be provided from the CHP budget next year to fund the alterations required to the specification particularly in relation to infection control. The Area Committee Manager agreed to seek clarity from the Locality Manager in relation to issues raised by Members. Upon receipt of the response from the Locality Manager the Area Committee Manager agreed to circulate the information to Members.

Decision

- 1. Members agreed to note the contents of the report; and
- 2. Congratulated the Campaign group and local organisations on raising an outstanding sum of money towards securing the pilot.

6. ROADS CAPITAL RECONSTRUCTION PROGRAMME 2015/16

The Committee considered a report which outlined the successful completion of the 3 year Roads Reconstruction Programme for 2012-2015 and outlined the proposed Roads Reconstruction Programme and Budget for 2015-2016. Discussion took place in relation to carrying out surface dressing on roads of a reasonable standard while roads which remain in a poor state of repair have no Capital money spent on them. The Contracts Manager explained that roads require to be in a reasonable condition before surface dressing can be applied and outlined the process in which roads are selected for inclusion in the programme. Further discussion was had in relation to certain roads within the locality. Members noted that the contract with Breedon was now over and that in so far as practicable the preparation of surface dressings and over-lay would be carried out in-house, with Keeley Brothers having been awarded the contract to carry out surface dressing. The Contracts Manager provided reassurance that where commitments could not be met in-house, they would look to tender the work.

The Contracts Manager agreed to provide Members with a more detailed explanation in terms of the criteria used for selecting roads for inclusion in the programme.

Decision

Members agreed to note the contents of the report.

7. CAMPBELTOWN FLOODING - POTENTIAL REMEDIAL WORKS

The Committee considered a report updating on the potential initiatives which may reduce the effects of flooding in Campbeltown, some background in relation to the 2008 Halcrow Report and the Scottish Government's Surface Water Management Plans initiative (SWMP). Members noted that Campbeltown is to be the subject of a SWMP and that the Council has engaged consultants to carry out a survey to ascertain road levels at John Street and Saddell Street. Discussion took place in relation to the timescales involved in progressing the sub-working group on flooding issues and the addition of the culvert at Tomaig Road. The Contracts Manager provided a commitment that the sub-working group would be set up before the next Area Committee meeting.

Decision

- 1. Members agreed to note the contents of the report; and
- 2. Agreed that a further report be brought to the Area Committee meeting in June, outlining the findings of the road level survey.

Ms Devine highlighted the wider achievements of the school and also the additional support available for pupils through the implementation of GIRFEC. Discussion took place in relation to the move towards becoming a dyslexia friendly school and the recruitment difficulties faced by many schools on a national level.

Developments through the Improvement Plan 2013/14

- A robust shared system of Quality Assurance was active in all levels of the school which included, production and monitoring of QA calendar, sharing of good practice/methods, feedback of findings/Actions (PT/SLT)
- Targets set were set for each individual and agreed to ensure students are performing in line with CATs indicators
- A new tracking and monitoring system set up in SEEMiS which led to reporting of progress being shared more regularly with parents/students
- A framework for skills development is being developed which will enhance the production of S3(2) profiles
- Introduce new curriculum Endeavour project
- A new Rewards/sanctions system was developed with students council which allowed students to earn merits towards badges
- Attendance was more closely monitored by Tutors/Student reports with regular reviews with pastoral/SLT link
- The school moved to use of Pastoral Notes and referral systems
- We began working towards becoming an Adventure Learning School with a series of staff training and development days

Curriculum Developments

The curriculum at Islay High School continues to evolve to meet the challenges of the Principles of Curriculum Design and keep abreast of CfE national developments

Session 2013-14 saw the replacement of all Standard Grade and Intermediate courses with the new National Qualifications. This lead to the introduction of new qualifications such as National 4 Lifeskill Mathematics and National 5 Modern Studies. This was the main focus of development within our unique senior phase and entailed a lot of work by staff and pupils alike. However, it was not the only development.

In response to the need to recognise wider achievement the school also ran the SQA Personal Development Award and the John Muir Award for the first time. In line with developing personalisation and choice within our curriculum the school continued to develop its co-curricular activities on

Wednesday and Friday afternoons. Included in the many activities on offer were opportunities to gain accreditation in NPA Dance, NPA Drama and Higher Psychology.

The school also worked in partnership with Argyll College offering Skills for Work courses in Cosmetology and also Early Education and Childcare.

The Junior Phase was also being developed by the introduction of Endeavour Projects to the S1 curriculum. These were a continuation and refinement of the personalised educational projects started in primary school and continue the element of pupil choice within the curriculum. Literacy classes were also allocated to the S1 curriculum to aid in the national drive to improve literacy standards.

In 2013-14 the pupils had a formal curriculum choice of 21 Higher courses, 21 National 4/5 courses, 3 other courses recognising wider achievement and 2 skills for work courses. They had opportunities to study 2 NPA courses in co-curricular time as well.

Building Refurbishment Work

Over the last few years the authority has invested a significant amount of money in upgrading the school building. Over the last year the following has taken place and planned:

- The re-wiring of the school is now complete
- The science base has been refurbished
- Server will be moved and new computer room completed
- General teaching rooms refurbished

Plans are still continuing to re-design some of the teaching spaces in school and the entrance area to the school building further stages of this work will take place this summer.

Staffing

There have been a number of changes to the staffing in the school over the last year.

Mrs Joanna Holmes, the Head Teacher, resigned in June 2014 after 18 months in post.

Mr Ian Stuart has been seconded to the Scottish government for 2 years. Mrs Norma Broad joined the English department and Mr Jonathon Broad has been working in our Student Support department. Mr Alan Beresford was appointed as Deputy Head Teacher at Rothesey Academy. Mrs Nicola Moran and Ms Karen Siddall were appointed as replacement for his role. Mr Graeme Johnston joined the mathematics department and Mr Neil Gallighan joined as teacher of art. Mrs Sadie Richie is retiring this summer after 25 years of service to the school. Mr Kam Sangha is taking a year's sabbatical to pursue further studies and Mr Jonathan Broad will be filling his post in the English Department. Ms Jenna Coburn left our PE department and will be replaced with Ms Rebecca Gibson. We will be appointing a Maths teacher and new librarian shortly.

Mathematics and Business Education Faculty

Mathematics Department

Students successfully took part in this year's Scottish Mathematics Challenge at both Junior and Middle level achieving:

- 1 gold award, 5 silver awards and 6 bronze awards at Junior level, and 3 silver awards at Middle level.
- Congratulations to the students pictured who all received awards in this year's National Maths Challenge competitions at both Junior and Intermediate level.
- Students learnt more about deciphering codes by taking part in the National Cipher Challenge, run by the University of Southampton.
- The department has run the Fantasy Football competition throughout the football season.
- S1 took part in the Young Apprentice challenge by having to design, make, market and sell their own game based on using multiplication skills.
- Whole school events were run to celebrate national Pi Day.
- In addition to resources provided on students individual computers, and through edmodo, students can now also access materials on www.mathsworkout.co.uk
- Mr Mike Senior gave a talk to our senior maths students on the development of number systems and the calculator which was both engaging and informative as well as interactive, with lots of exhibits for students to try.
- Throughout study leave staff have been involved in visits to the local primary schools.
- After school supported study has run twice weekly throughout the year in addition to a Monday homework lunchtime club.
- Staff attended the Scottish Maths Conference in Stirling and attended workshops which supported the learning of students in Islay High School.
- Parental workshops were run for the parents of those students sitting higher maths and higher English.
- Former student, Mr Ben Harrison, now teaching maths in Williamwood High School visited the department, as did staff from local primary schools.

Business Education Department

Students took part in the Coca Cola Real Business challenge which involved them creating a business plan for a new soft drink.

- Within the Young Enterprise competition this year students actively raised money for their projects by running a successful coffee morning and providing a catering service for the local Gaelic Choir, rehearsing that day in the community hall. The students then ran several profitable ventures from jewelry to mobile phone covers and bespoke candle holders.
- 6 teams took part in this year's Student Investor competition which linked in with their Business courses.
- The P4/5 class from Port Ellen Primary School visited the department to learn new ICT skills and develop a spreadsheet to take back to their school to be incorporated in their Enterprise venture.
- Students enjoyed developing revision materials using powtoons for the first time.

Art, Design Technology Faculty



- Publication: We have continued to help many departments and events with publicity photos and poster production to advertise the various event which happens within and around the school.
- Windows 8.1: We have started to roll out the new version of Microsoft's Windows operating system. Windows 8.1 will become the standard operating system soon throughout the council and we will be leading the way along with a few other schools in its implementation. This operating system will be very suitable for our current setup as almost all computers within the school are touch capable devices.
- New Computers: We are continuing to refresh our stock of computers within the Argyll and Bute 'Computer Refreshment Scheme'. Our current stock of Dell Computers will be replaced this year with a new Toshiba device and Daniel and Walter are working hard to get these devices set up for the new term.
- Travelling Gallery: The Travelling Gallery, a National Lottery funded arts organisation, visited the High School on Monday 28th of April. Contemporary artist Rachel MacLean's exhibition of her work 'I HEART SCOTLAND' was on display, S1, S2 and pupils from the four Islay Primary schools were in attendance and an educational experience was had by all.
- Ceramics: \$1 & \$2 pupils have had a new experience of creating clay vases, tiles, pots and sculptures of animals. These items were then glazed to create the finished pieces. Older pupils have also been enjoying this 3D art form during the Ceramic Core class on Friday afternoon.
- MOD T-shirt Competition: Pupils designed T-Shirts for this year's MOD ILE team. Each design incorporated the pupils
 own Gaelic Slogans with the help of the Mr Bond in Gaelic Department. Happily an S1 pupil's design was selected
 as the winner and their design will be worn by all of the participants of the MOD ILE team at this year's MOD in
 Inverness, which will be and featured on BBC ALBA.
- Baillie Gifford Art Competition: Three pupils from Islay High School submitted work to the National Baillie Gifford
 Art Competition in January for the chance to win a cash prize for themselves and their school. Unfortunately we were unsuccessful, however the artwork submitted was of a very high standard and a credit to the school.
- S1 Interdisciplinary Highland Games: S1 pupils in Art & Design designed and made fabric banners to be used at this year's S1 Highland Games on Monday 19th May. Pupils also designed logos for the house t-shirts and it is hoped that the best designs will be printed into real t-shirts and worn at future inter-house competitions and events.
- S2 Personal Health Project: S2 pupils in Art & Design created their own imaginative Personal Health Plan front covers for the booklets they will be creating in PE. These were made on the Macromedia Fireworks Program. Pupils considered their diets and personal fitness goals and incorporated these ideas into their designs.

Science and HE Faculty

The faculty is very much involved in the life of the wider school.

Core activities:

- Chess Club
- Supported Study
- Issues in Science and Technology
- Craft Baking and Practical Cookery

Extra-curricular:

- The breakfast club (Tuesdays and Thursdays) is at the heart of science and H.E.'s contribution to the Health and Wellbeing agenda for the school. This works in partnership with LAPA and staff from both faculties offer regular voluntary work.
- The biology after school club which operates twice weekly throughout the year.
- The physics after school club operates every Tuesday evening throughout the year.
- Chemistry and H.E. both offer extra-curricular support, sometimes even at weekends, on demand from students.
- Staff give freely of their time to support student learning and success. This includes the offering of Advanced Higher level courses (not timetabled) for physics, biology, chemistry and home economics.
- Science Club, targeted at younger students, runs when time and demand exist.

Interdisciplinary:

- The faculty is a partner in the following regular interdisciplinary events:
- NSEW with the P7s from across Islay and Jura
- Personal Health Plan with S2s. Involved: Home Economics, p.e., biology, numeracy, literacy
- The faculty also participates in the following events which occur on a biennial or similar basis:
- Marine awareness week with \$1. Involved: biology, geography, numeracy.
- Energy and fossil fuels with \$1. Involved: science, geography, numeracy.
- A number of smaller scale interdisciplinary activities take place within the faculty; e.g. world food and H.E., topical science projects biology and ethics, fuel resources, earthquakes

Working in partnership with others:

- National Science and Engineering Week event with P7s from across Islay and Jura: Bowmore, Port Ellen, Small Isles, Port Charlotte and Keills.
- Biology working with RSPB, Islay Natural History Trust and more broadly, science working with Islay Energy Trust.
- Visiting speakers from Heriot-Watt University (Physics) and Liverpool John Moore University (Astrophysics).
- Working in collaboration with primary schools; e.g. PK's visits to assist with Port Ellen primary's science week, JMN working with Port
 Charlotte museum and RSPB reserves, PK visiting to work with Small Isles primary technology challenge project.
- Pioneering work with CfE and most recently the revised higher physics course as a national early adopter.
- The faculty works closely with SCHOLAR, especially supporting higher and advanced higher courses across the school, and maths at each level through PK's involvement with SCHOLAR.
- SQA work at various levels in biology (JMN) and physics (PK) with obvious benefits to the student support and teaching in the faculty. This has involved the development of questions and support material, and marking at levels up to Advanced Higher.

• Participation in the "Island Universe" program of astronomy work (in association with the National Schools Observatory) and with a visit to the school including public lecture, in September 2013.

Further developments:

- Exploring links with STEM ambassadors
- New Core activity under development involving visits and more connections in the wider community
- Strengthening links with Heriot-Watt and exploring other links with higher education providers

Literacy & Performance Arts Faculty

English/Drama

- \$1/\$2 curriculum we tried a much wider combined approach using a novel as the thematic basis for studying other works e.g. poetry. Much bigger emphasis on critical reading too research in a variety of situations and on writing/note-taking in own words.
- S2 Drama –Gave outcomes/experiences/expectations and pupils helped to choose their own curriculum which suited their needs.
- All National 4 pupils passed the course. Discussion about Nat 4 helped confirm we were on the right lines with the new course.
- N5 courses written managed to cover all the genres (drama, poetry, prose) as well as critical reading and research; also creative, personal, discursive/persuasive and report writing. Cross-marking helped to confirm standards for Nat 5 and Higher.
- Communication within the department and cross-marking/exchanging materials/ideas
- Teaching film to all classes to secure foundation in critical appreciation
- Making of anti-bullying ads with S1, involving mixed media
- Instigated creative writing competition and Project-based learning

Music

- Uptake for subject has sustained increase from 5 Int. 2 pupils to 10 N5 pupils and 1 Higher pupil to 8 (predictions would indicate a high level of success). Indications from option choices represent a sustained interest in the subject too
- successful summer/Christmas concerts; standards are improving
- choir and Trad group have continued to flourish
- National Youth Band Jazz Workshop at least 40 pupils involved
- choir trip to Edinburgh 'Lion King'

Instrumental and Concert Band Review

Islay High School

The school now has a junior and a senior band and both have been very active and these provide a valuable avenue for students taking individual lessons to take their music further while benefitting from the discipline, performance and social interaction the band experience offers. Highlight include:

- School Band Concerts in October, Christmas and March
- Peforming at the Kilmenny Church "Songs of Praise" service and the Christmas Carol Service
- Informal Concert at Gaelic College
- Instrumental Open Evening for P7 to S3 students
- ABRSM Practical examinations (100% success rate)
- Alba Brass Concert & Workshops with visiting professional
- Performing at Trust Housing in Bowmore and at the Gortonvogie Care Home
- Band Trip to Glasgow
- Competing at the Mid Argyll Music Festival in Lochgilphead

Social Subjects and Languages Faculty

As well as developing our new national qualifications we have run a range of enrichment activities.

Gaelic - The John Muir Award program was again run for students at Islay High. Working with RSPCA camera traps and time-lapse were set up at Gruinart with sessions from CnaG's Dòmhnall Morris, and James How and Mary Redman from the RSPB. All students gained an award and the program ended with a residential in Applecross where students presented their film.

History - Students in S1 and S2 took part in the aspire inspire competition to commemorate the Second World War

People and Society - Students have been investigating their local area though a survey of Bowmore, a visit to the local museum and a tour of the Bowmore Whisky Distillery

Modern Studies - Students worked with the local police to investigate crime on the Island and ways of promoting a safer community. They produced crime talks as part of their assessment based on their work.

Spanish - Pen pal scheme has continued with Spanish students.

PHYSICAL EDUCATION (including Health and Well Being)

- Sports leaders/Young Ambassadors have been well utilized within school and the community
 including supporting the delivery of PE in our cluster primary schools. The 4 Young Amassadors also
 attended the National Youth Sports Leadership Conference at Strathclyde University
- Inspire/Aspire competition 3 pupils made it to the national finals
- Enhanced involvement with partners development officers, active schools, NHS
- Landscape architect produced plans for pitch development
- Participation in inter-house activities was high
- Regular sporting competitions with other schools in the MAKI League
- Rugby trips included competing against Bishopriggs High School with the South Argyll Rugby Squad and attending \$1/\$2 Festival of Rugby in Lochgilphead
- We have had enhanced involvement with partners development officers, active schools and the NHS
- Steve Frew, Scottish gymnast and Commonwealth Gold medallist visited the school and ran workshops with students as part of the SKY SPORTS Living For Sport programme. The school also organized an S1 Foam Polo tournament as part of the same programme.
- The PE Dept., together with the Art, Maths and Music departments, lead an interdisciplinary task where all of S1students competed in a Highland Games competition.
- Heavily involved in fundraising: Sport Relied raising £1134 by having the whole school take part in a sponsored walk and \$1 Raised £1005 from sponsored runs

New Qualifications

John Muir Award: Islay High School delivered the John Muir Award for the first time in 2013/14 with 8 pupils taking the class. The award was based around the school garden. The group spent the year building a large pond, clearing evasive plants, planting wildflowers and other plants to attract native wildlife to the garden. They made bird feeders during the winter. Paved a seating area in the garden and painted planters, tubs and benches to make the garden more colourful and interesting for students to visit

Alongside doing this the group also volunteered at Islay Community garden helping the staff to clear evasive plants and get the ground ready for planting.

Members of the class have also been taking care of chickens within the school. They have maintained the hen house.

Islay High School

Personal Development Class: The personal development class has had a busy year during the 2013/14 school terms. The class aimed to help develop, support and challenge the young people in their personal skills. The class worked together to organise a lunchtime fun session where they had sporting activities, board games, Wii and a chill out area. This first challenge helped the 6 students to take their first step at building their confidence and develop their skill set at working within a team. The class's next project was to raise money for the elderly in the community by organising a quiz night!



The young people developed their leadership roles and commented about how much more confident they felt in their own abilities since the start of the course. The group have also been involved in sponsored walks, making substance misuse displays and work experience, where they planned and organised their own work experience placement.

Wider Achievement

The school prides itself in the amount of extra-curricular and residential experiences it offers the students, which allows students to excel in non-academic areas. The following will give you a flavor in regards to the varied wider achievement of our students.

Boatbuilding: This year senior students have been involved in the construction of 2 hand built St Ayles Skiffs, supported by a local craftsman. Both boats were successfully launched on June 20th with a school rowing competition and later in the evening with a community event. Not only is this giving us an opportunity to allow students to be involved in more outdoor activities but we have made excellent relationships in the community, supporting Bowmore Pier by housing the skiffs there but our students have developed skills that could potentially lead to employment in the future.



Loch Eil Outward Bound: In February, all of our S2 students attended our annual 5-day residential experience at the Loch Eil Outward Bound Centre near Fort William. This is an excellent program aimed at developing self-esteem, confidence, leadership and teamwork skills, target setting and responsibility. It's challenging and hard work but the students have great fun and gain enormously from the experience. They all gained a John Muir award on return to school and completing a presentation.

Expedition to Ethiopia (Summer 2013): Eleven senior students took part in a 1-month expedition to Ethiopia. We deliver these expeditions every two years as an intense personal development program designed to provide young people with the adventure of a lifetime while at the same time developing essential transferable life skills to a high level. The skills, experience and confidence that the group will gain from achieving this venture will be immense. Aspects of the itinerary include;

- Working at the 'Children's Heaven' orphanage
- High altitude trek in the Simien Mountains
- Home-stay experience in high altitude remote village near Lalibela
- Two day trek and camp in National Park in the Rift Valley
- Rest & Relaxation Lake Langano

Rezoning Request by Achahoish Parent Council

1. EXECUTIVE SUMMARY

The proposal to vary the catchment area of a school is a relevant proposal in terms of Schedule 1 of the Schools (Consultation) (Scotland) Act 2010.

The 2010 Act has recently been amended by the Children and Young People (Scotland) Act 2014. The amendments which came into force on 1st August 2014 include a requirement for a report from Education Scotland in the case of every proposal requiring consultation. Guidance has been prepared by the Scotlish Government to support implementation of the amendments. In September 2014 Argyll and Bute Council Community Services Committee:

- a) Noted the amendments to the Schools (Consultation) (Scotland) Act 2010, the revised timeline and process for the public consultation.
- b) Approved the process by which future requests to alter the catchment area of a school be considered.
- c) Agreed that any proposal received from a Parent Council being taken forward to a public consultation would require to have the support all parent councils affected by the proposal.
- d) Agreed that subsequent requests for altering the catchment area of a school following either a decision to refuse a request to do so or a decision following the publication of the consultation report not to proceed with such an alteration will only be considered if there has been a material change of circumstances from those originally considered.
- 1.1. In May 2014 Achahoish Primary School Parent Council made a formal request to the council to consider rezoning their current catchment area.
- 1.2. Rezoning requests received since 2010 have not been considered due to the advice from the Scottish Government that the legislation was not fit for purpose and subsequently the report of the Commission for Rural Education which recommended amendments to the legislation.
- 1.3. The Council administration has made it clear that they have no plans to review the school estate at this time and the recommendations in the report prepared by the Commission for Rural Education are being considered by the Scottish

Government and COSLA, joint commissioners of the report. However, none of the 38 recommendations in the report would prevent us from reviewing school catchment areas at this time

- 1.4. Three requests relating to rezoning of catchment areas have now been received by the Executive Director of Community Services, these being:
 - Strone Primary School Sandbank Primary School
 - Achahoish Primary School Tarbert Academy (Primary Dept.)
 - North Bute Primary School Rothesay Joint Campus (Primary Dept.)

This report refers to the second of these three requests.

2. RECOMMENDATIONS

- 2.1 That the Mid Argyll and Kintyre Area Committee:
 - Considers the request of Achahoish Parent Council to increase the catchment area of Achahoish Primary School (PS).
 - Supports the recommendation that if the proposal be approved existing children and younger siblings would not be required to transfer school for the duration of their primary education as a result of the proposal.
 - Decides whether the report should be presented to the Council in June 2015 to request officers are instructed to carry out a full consultation on the proposed change as defined in the Schools (Consultation) (Scotland) Act 2010.
 - Notes that on completion of the consultation period a report will be presented to Council detailing the results of the consultation for consideration.

Rezoning Request by Achahoish Parent Council

3. INTRODUCTION

The proposal to vary the catchment area of a school is a relevant proposal in terms of Schedule 1 of the Schools (Consultation) (Scotland) Act 2010.

The 2010 Act has recently been amended by the Children and Young People (Scotland) Act 2014. The amendments which came into force on 1st August 2014 include a requirement for a report from Education Scotland in the case of every proposal requiring consultation. Guidance has been prepared by the Scotlish Government to support implementation of the amendments. In September 2014 Argyll and Bute Council Community Services Committee:

- a) Noted the amendments to the Schools (Consultation) (Scotland) Act 2010, the revised timeline and process for the public consultation.
- b) Approved the process by which future requests to alter the catchment area of a school be considered.
- c) Agreed that any proposal received from a Parent Council being taken forward to a public consultation would require to have the support all parent councils affected by the proposal.
- d) Agreed that subsequent requests for altering the catchment area of a school following either a decision to refuse a request to do so or a decision following the publication of the consultation report not to proceed with such an alteration will only be considered if there has been a material change of circumstances from those originally considered.
- 3.1. In May 2014 Achahoish Primary School Parent Council made a formal request to the council to consider rezoning their current catchment area.
- 3.2. Rezoning requests received since 2010 have not been considered due to the advice from the Scottish Government that the legislation was not fit for purpose and subsequently the report of the Commission for Rural Education which recommended amendments to the legislation.
- 3.3. The Council administration has made it clear that they have no plans to review the school estate at this time and the recommendations in the report prepared by the Commission for Rural Education are being considered by the Scottish

Government and COSLA, joint commissioners of the report. However, none of the 38 recommendations in the report would prevent us from reviewing school catchment areas at this time

- 1.4. Three requests relating to rezoning of catchment areas have now been received by the Executive Director of Community Services, these being:
 - Strone Primary School Sandbank Primary School
 - Achahoish Primary School Tarbert Academy (Primary Dept.)
 - North Bute Primary School Rothesay Joint Campus (Primary Dept.)

This report refers to the second of these three requests.

4. RECOMMENDATIONS

- 4.1 That the Mid Argyll and Kintyre Area Committee:
 - a) Considers the request of Achahoish Parent Council to increase the catchment area of Achahoish Primary School (PS).
 - b) Supports the recommendation that if the proposal be approved existing children and younger siblings would not be required to transfer school for the duration of their primary education as a result of the proposal.
 - c) Decides whether the report should be presented to the Council in June 2015 to request officers are instructed to carry out a full consultation on the proposed change as defined in the Schools (Consultation) (Scotland) Act 2010.
 - d) Notes that on completion of the consultation period a report will be presented to Council detailing the results of the consultation for consideration.

5. DETAIL

- 5.1 The existing boundary between the current catchment areas of Achahoish PS and Tarbert Academy Primary is shown in appendix 1. The request by Achahoish Parent Council was for the catchment area to be increased. The preferred choice for boundary change is for Achahoish School to Tiretigan Farm, Kilberry appendix 2.
- 5.2 The decision by Council to close Kilberry Primary School in June 1979 resulted in the catchment area of Tarbert Academy PS being extended to incorporate the old catchment area of Kilberry PS. This has resulted in the pupils from Kilberry being expected to attend Tarbert Academy PS.
- 5.3 Achahoish Parent Council, supported by South Knapdale Community Council, feels that this decision was not correct and is now requesting that Achahoish PS catchment area be extended to include some of the old Kilberry PS catchment area.
- 5.4 At a meeting of Achahoish Parent Council on 11th March 2015 the proposal was discussed and a new proposed boundary identified. One councillor attended the meeting and several councillors made representations. The Head Teacher was present.

5.5 The proposal by Achahoish Parent Council is supported by Tarbert Academy Parent Council. As stated in the School Rezoning Policy, support for a boundary change is required from both schools' parent council. A letter of support from Tarbert Academy Parent Council has been submitted.

From the new proposed boundary the distance to Achahoish PS is 9.6 miles. The distance to Tarbert Academy is 13.7 miles. All travel in this area is on a single track road with passing places.

5.6 The area proposed to be transferred contains 24 properties eligible for Council tax, seven of which are second homes, all seven receive second home council tax reduction.

The authority is aware of 2 children of primary school age living in the area, 2 of whom currently attend Achahoish PS. These two children are on a placing request. The family receive parental mileage to meet the present school bus arrangements. There is another family, whose children will start school in 2017, who have moved away temporarily. The family intend to return when they have built a house within the new proposed catchment area. This family have written a letter explaining their intention.

- 5.8 School transport is currently provided to 5 children between Achahoish School Kilmaluaig. This is an existing service bus route. Route Number 421 operated by West Coast Motors, between Kilmaluaig, Lochgilphead and Ford. Leaving Kilmaluaig 09.00 and arriving at Achahoish Primary School at 09.17. The bus travels on to arrive at Lochgilphead Joint Campus at 08.44 and the final destination at Ford at 10.27. Pupils from Achahoish Primary School are picked up on their homeward journey at 15.35 by the bus which has left Ford at 14.24 arriving at Kilmaluaig at 15.47. Two children are then collected by parent transport travelling to Coulaghailtro.
- The respective rolls of Achahoish PS and Tarbert Academy PS are given below. The table below shows the census figures for 2000, 2005, 2010 and roll as advised by Achahoish PS and Tarbert Academy PS week beginning 9th March 2015. Achahoish PS has a maximum capacity of 42 pupils and Tarbert Academy PS has a maximum capacity of 163 pupils.

The roll of Achahoish PS in 2015/16 is expected to be 11, and in 2016/17 is expected to be 10 children.

5.10 Achahoish PS has two placing requests travelling in to the school and no children travelling out of the school. These two children live in the new proposed catchment area for Achahoish PS. Tarbert Academy PS has two placing requests travelling in to the school and six children travelling out of the school.

- 5.11 The Single Outcome Agreement seeks to reverse population decline and is supported in this by the Local Development Plan, which identifies and promotes housing development sites. The following evidences future development potential in the area as indicated by allocations for housing in the Adopted Local Development Plan 2015 and planning permissions in the locality of Achahoish. The new Local Development Plan identifies three areas for housing development. One area allocated for ten houses, including 25% affordable (H3004) and two further areas totalling 2.16ha allocated for medium density housing (PDA12/53 and PDA12/55 starting at 17 houses per ha.) There is also possibility of windfall development out with the allocations and potential development areas but in accord with the settlement strategy. The following applications were approved for housing in the Achahoish catchment in the 3 years up to 01/04/2014 but will lapse after 3 years from decision date unless development has commenced.
- 5.12 Achahoish is not included as a priority in the Strategic Housing Investment Plan. No housing pressures or requirements have been identified.

6. Impact of changes

- 6.1 This proposed change affects one family who currently attend Achahoish PS on a placing request. In the future it may mean a family who intend to return to the area will attend Achahoish rather than Tarbert. For the next two years the pupil numbers at Achahoish are expected to remain very similar therefore staffing will not be affected. It will have no impact at present on Tarbert Academy Primary
- The family furthest from Achahoish PS, who attend on a placing request travel 7.4 miles to Achahoish PS. The distance to Tarbert Academy PS is 15.6 mile, more than twice the travel distance to Achahoish Primary. All travel in this area is on a single track road with passing places.
- 6.3 The travel time from Coulaghailtro (where the furthest travelled family live) to Kilmaluaig and on to Achahoish PS is 25 minutes total. The travel time from Coulaghailtro to Tarbert Academy PS is 49 minutes. Effectively, by moving the Achahoish PS boundary to Tiretigan, travel time is reduced from 49 minutes to 25 minutes, decreasing the daily travel for children significantly.
- 6.4 If the council is minded to approve this boundary change there will be considerable impact on school transport both method and cost.
 - There will be a requirement to purchase a vehicle and employ a driver and escort. This will cost approximately £15k per annum, providing a driver and escort can be employed from the Coulaghailtro area. The cost will rise to £22,500 if the driver and escort are resident in either Tarbert or Lochgilphead, or
 - The local bus service could be extended to Tiretigan the cost for this would be £23,000.

- 6.5 The proposal will not affect the existing arrangements for pupils going to secondary schools. The boundary change will however create a unique situation in that pupils from Achahoish Primary School who have learned together through primary school will then attend different secondary schools.
- 6.6 The proposal is not anticipated to have any impact on any other school in the area.
- 6.7 The South Knapdale Community Council supports the proposal. They state that this change could encourage young families to remain or even move in to the Kilberry area as children can attend the nearest school safely and with cost free transport over a relatively short distance.
- 6.8 Any transport arrangements that are in place at present or in the future could be affected by families moving in to the area.

7.0 Next Steps

- 7.1 The proposal from Achahoish Parent Council to increase their catchment area qualifies as a permanent change to a school as defined in the Schools (Consultation) (Scotland) Act 2010.
- 7.2 As detailed in the September 2014 Argyll and Bute School Catchment Area Policy, the proposal to vary the catchment area of a school is a relevant proposal in terms of Schedule 1 of the Schools (Consultation) (Scotland) Act 2010.

Therefore if the Council makes such a proposal it requires

- to prepare an educational benefits statement.
- prepare and publish a proposal paper
- give notice of the proposal to relevant consultees and invite representations
- to hold and give notice of a public meeting
- to involve Education Scotland
- 7.3 If Council were to approve the proposal by Achahoish Parent Council, officers would begin steps 2 to 5. The full consultation report, step 6, would be presented to Council after the summer recess for a decision on the proposal.
- 7.4 Education Scotland has also indicated that it expects councils to properly reflect on their comments prior to finalising their reports
- 7.5 If Council were mindful to agree the changes to the boundary of Achahoish Primary School these changes could be made in time for registration for the 2016/17 academic year.



- 8.2 Financial There will a cost to the service in carrying out a public consultation. If a change is approved there will be a requirement to
 - Purchase a vehicle and employ a driver and escort. This will cost approximately £15k per annum, providing a driver and escort can be employed from the Coulaghailtro area. The cost will rise to £22,500 if the driver and escort are resident in either Tarbert or Lochgilphead, or,
 - Extend the local bus service to Tiretigan. Due to timetabling constraints this extension would only be possible in the morning. The afternoon run would require to be undertaken by council mini bus from Lochgilphead. The cost for this extension would be £23,000.

- 8.4 HR there are no HR implications
- 8.5 Equalities an equalities impact assessment will be carried out as part of the consultation.

1 Background

MAKI FERRY ISSUES INCLUDING CAMPBELTOWN TO ARDROSSAN FERRY SERVICE

1.0 EXECUTIVE SUMMARY

- 1.1 This report provides an update on ferry issues affecting the MAKI area.
- 1.2 There have been a number of concerns raised with regard to the reliability of the ferry service to islands in the MAKI area particularly over the Easter period which is economically important to our island communities. In response to this issue the Council has liaised with the ferry operator CalMac to talk about this issue with Members and other key stakeholders as appropriate. CalMac have subsequently prepared a presentation on their performance including the question of reliability and the reasons why this is happening and why decisions are being taken.
- 1.3 Another issue of importance dealt with in this report concerns the potential transfer of council run ferries to Transport Scotland and their preferred operator once appointed following the current tender process.
- 1.4 The report also deals with the third year of a pilot ferry service between Campbeltown and Ardrossan is about to commence. The main purpose of this report is to outline the findings of the surveys taken during the pilot's second year. Transport Scotland will evaluate the findings of all three years of the pilot before making a recommendation as to whether or not the service will be extended beyond the pilot's three year period.
- 1.5 This evaluation will seek to assess the extent to which the pilot service has met its objectives:
 - To provide a boost to the Campbeltown economy and develop Campbeltown as an attractive place to visit, work and do business.
 - To enhance the transport choices and links for local people and businesses in the Kintyre peninsula.
 - To increase visitors to Campbeltown and the Kintyre peninsula and support existing tourism markets and develop new opportunities.
- 1.6 Studies conducted by Vector research shows that the service is more popular with Campbeltown and South Kintyre residents than it is with residents of Ardrossan, Saltcoats and Stevenston. Out of the households in Campbeltown and South Kintyre, 99% reported an awareness of the pilot service and 42% reported using the

service. In the Three Towns 56.4% reported awareness and only 3% reported using the service. Over 40% of businesses in Campbeltown report an increase in turnover during the period, whereas just over a quarter of businesses in Ardrossan reported a similar increase.

Transport Scotland will examine all 3 years of the pilot scheme before coming to any conclusion whether or not to recommend the extension of the ferry service into future years.

2.0 RECOMMENDATIONS

2.1 That the Area Committee notes the report and agrees a date for the presentation by Cal Mac on ferry performance in the MAKI area.

MAKI FERRY ISSUES INCLUDING CAMPBELTOWN TO ARDROSSAN FERRY SERVICE

1.0 INTRODUCTION

- 1.1.1 There have been a number of concerns raised with regard to the reliability of the ferry service to islands in the MAKI area particularly over the Easter period which is economically important to our island communities. In response to this issue the Council has liaised with the ferry operator CalMac to talk about this issue with Members and other key stakeholders as appropriate. CalMac have subsequently prepared a presentation on their performance including the question of reliability and the reasons why this is happening and why decisions are being taken.
- 1.1.2 Another issue of importance dealt with in this report concerns the potential transfer of Council-run ferries to Transport Scotland and their preferred operator once appointed following the current tender process.
- 1.1.3 The Campbeltown to Ardrossan ferry service which runs from May to September is entering its third and final year of a pilot study that has been running since 2013. Transport Scotland will undertake an evaluation of the service during this year, looking at all three years of the pilot, reporting on the viability of the continuation of the service beyond 2015.

2.0 RECOMMENDATIONS

2.1 That the Area Committee notes the report and agrees a date for the presentation by CalMac on ferry performance in the MAKI area.

3.0 DETAIL

3.1 In response to the issue of ferry reliability in the MAKI area issues were discussed with the ferry operator CalMac. CalMac explained that the fleet they have to work with has an average age of over 20 years which brings with it particular issues over reliability and performance. Additional issues such as limitations on how many hours crew can work, availability of spare vessels that can use the existing ferry infrastructure, where boats can be serviced and the availability of parts are also issues that impact on performance together with the weather and associated climate change issues. That said CalMac stated that their reliability remained good despite recent incidents and have prepared a detailed presentation on the issues they face and the procedures they follow when decisions are taken to call off a service or utilise/divert another vessel. CalMac would be happy to give this

- presentation to Members and other key stakeholders at a suitable time and this report asks Members to consider a possible date for this to happen.
- 3.2 Another issue of importance dealt with in this report concerns the potential transfer of Council-run ferries to Transport Scotland and their preferred operator once appointed following the current tender process. The Council has been in detailed discussions on this issue with representatives of Transport Scotland and the potential impacts of such a transfer. The Council has entered these discussions on the basis of ensuring that ferry services to our islands are maintained to the current level or indeed improved. Full financial information has been passed over to Transport Scotland together with a detailed list of Council assets including land associated with the ferries, slips or infrastructure and the ferries themselves. Transport Scotland representatives have not yet responded to this information which will be critical in the final recommendation to Council on whether to transfer or retain responsibility for the operation of the ferry services currently run by the council.
- 3.3 With regard to the Ardrossan to Campbeltown route Vector Research in association with JMP Consultants, have been commissioned by Transport Scotland to undertake an evaluation of the Campbeltown to Ardrossan pilot ferry service which runs from May to September on a Thursday to Sunday inclusive between 2013 and 2015. The evaluation will seek to assess the extent to which the pilot service has met its objectives:
 - To provide a boost to the Campbeltown economy and develop Campbeltown as an attractive place to visit, work and do business.
 - To enhance the transport choices and links for local people and businesses in the Kintyre peninsula.
 - To increase visitors to Campbeltown and the Kintyre peninsula and support existing tourism markets and develop new opportunities.
- 3.4 Passenger and vehicle returns for the ferry service in 2013 and 2014 show a fairly constant trend. 7484 passengers and 1226 vehicles used the ferry in 2013, with 106 sailings averaging 70.6 passengers and 11.6 vehicles. In 2014, 6666 passengers and 1124 vehicles used the service, averaging 67.3 passengers and 11.5 vehicles.
- 3.5 To inform the evaluation a baseline report was completed in September 2013 to provide a backdrop to the data collected in both 2014 and 2015. Vector Research has undertaken and completed the 2014 wave comprising on-board passenger surveys and telephone surveys with local businesses and households in both Campbeltown and South Kintyre and Ardrossan, Saltcoats, and Stevenston (the Three Towns). 1,578 people responded to the passenger survey and 200 households responded to the telephone survey with 180 businesses also responding.
- 3.6 From the businesses in Campbeltown and South Kintyre, 43.5% of respondents claimed that turnover increased in the past 2 years, whilst 13.5% claimed that turnover had decreased. Businesses in the Three Towns report a less favourable response with only 26% claiming an increase in turnover with 14.3% claiming turnover had decreased. Of those claiming an increase in turnover in Campbeltown

and South Kintyre, 66.7% attribute at least a minor role to the arrival of the ferry. Almost a quarter, 23.1%, claim that the ferry had played a significant role. In the Three Towns a quarter of those in growth felt that the ferry had played a minor role in that increase.

- 3.7 Out of the households in Campbeltown and South Kintyre, 99% reported an awareness of the pilot service and 42% reported using the service. In the Three Towns 56.4% reported awareness and only 3% reported using the service.
- 3.8 The passenger surveys indicated that just over half of trips (55.3%) are for holiday short breaks or days' out. Other key purposes identified included visiting friends and relatives (18.1%), commuting to and from work (8.6%), and those using it for shopping (3.5%). Around 40% of those interviewed would not have made the trip in the absence of the ferry service and around 30% travel one way by ferry and use an alternative mode for the other journey.

4.0 CONCLUSION

- 4.1 Members have raised issues with CalMac's service reliability over recent months and Council officers have contacted CalMac to ascertain the reasons problems have arisen over reliability particularly over the easter period which is an important economic period for our Island Communities. Cal Mac have prepared a detailed presentation on the issues they face and their policies in dealing with ferry reliability which they are keen to present to Elected Members and other key stakeholders that make use of the ferry network. This report asks for a date to be agreed for this presentation to be given that is convenient for all parties.
- 4.2 Council officers are in discussions with Transport Scotland representatives over the potential transfer of the Council's ferry services and the preferred operator of the Scottish Government. The Council has supplied all requested information and is awaiting a response in the next month or so which will be reported back to Members.
- 4.3 Analysis for the final year of the pilot has obviously still to be achieved and it would be premature to come to any conclusions prior to the third year of the pilot being conducted. Analysis of the results over the last 2 years shows that the service is more popular with the residents and businesses of Campbeltown and South Kintyre than it is for the residents of the Three Towns. Transport Scotland will examine all 3 years of the pilot scheme before coming to any conclusion whether or not to recommend the extension of the ferry service into future years.

A verbal update, following the group meeting, will be provided at the Area Committee.
- 1.3 Should additional funding be required to implement any of the new initiatives, a further report will require to be presented to the Policy and Resources Committee for their consideration.
- 1.4 It is recommended that Members note the contents of this report.

FLOODING IN CAMPBELTOWN - POTENTIAL REMEDIAL WORKS

1. INTRODUCTION

1.1 This report follows on from the report presented to Members at the April Area Committee. The April report provided Members with a list of potential initiatives which could reduce the effects of flooding in Campbeltown. This report provides some background to the forthcoming 'working group' meeting arranged for 26th May 2015.

2. RECOMMENDATIONS

It is recommended that Members note this report.

3. BACKGROUND

- 3.1 Members have previously been advised that a permanently engineered solution, which fully addresses surface water flooding in Campbeltown, is not deliverable given current funding levels and numerous competing demands.
- 3.2 Surface water flooding in Campbeltown has generally occurred after overtopping of surface water at Millknowe which flows down to the low point of the town at Saddell Street and John Street causing flooding in that area. The information contained in the detail to this report will form the basis for discussions at the forthcoming 'working group' meeting.

4. DETAIL

- 4.1 As discussed with Members at the April Area Committee, options are being considered, which could reduce the effects of flooding in Campbeltown; these fall into three broad categories:-
- Pumping Temporary or permanent pipework and pump to remove flood water from the Saddell Street and John Street area to the Esplanade. Pumping should affect water levels at property frontages and reduce the threat of flooding.
- Vertical Realignment of footway / carriageway A level survey has been carried out at Saddell Street and John Street (the low point in the town) to allow some consideration of possible changes in kerb levels to divert water away from properties. Survey information will be the subject of discussion at the forthcoming working group meeting.
- Physical protection of properties Advice has already been provided to property owners regarding possible measures which they could take to protect their properties.

- 4.2 The three options listed in 4.1 above will provide some protection against the effects of flooding. The working group will aim to 'alleviate the effects of flooding in the low area of the town by utilising practicable solutions which must be realistically achievable given existing financial constraints'. The group will feed back to the Area Committee on a regular basis until the work of the group has been concluded a verbal update will be provided to Members at the June Area Committee.
- 4.3 Should additional funding be required to implement any of the above initiatives, a further report will require to be presented to the Policy and Resources Committee for their consideration.

5. CONCLUSION

This report provides information on action to be taken to reduce the effects of surface water flooding in Campbeltown.

1.0 EXECUTIVE SUMMARY

This report outlines progress to date in the delivery of the CHORD Campbeltown Berthing Facility Project with specific information on the operator tender and the critical timeline for completing the project.

As outlined in the previous update of 8 April 2015, the primary risks concerned the sourcing of an appropriate operator and the completion of the piling. The risks concerned with the piling have been addressed and have been secured within the budget and project timeline. An operator was appointed on the 11th May 2015.

It is anticipated that the berthing facility will be fully operational and open for business in May 2015 in time for the start of the sailing season.

It is proposed to have an official opening on the 27th June 2015.

Therefore, additional preparation time is now required to work up specific actions with partner organisations that were unable to be present on 6th May.
- **3.4** Furthermore, the Council's Strategic Management Team has also requested that they have an opportunity to input to the area-based EDAPs. This process will take place during June 2015, to ensure the Mid Argyll, Kintyre and the Islands EDAP is recirculated to all partners and stakeholders for further comment prior to the submission of the plan and a supporting paper on Monday, 20th July for discussion at the pre-agenda meeting on Wednesday, 29th July 2015.
