# MINUTES of MEETING of CAMPBELTOWN COMMON GOOD FUND held in the INVERARAY PRIMARY SCHOOL on WEDNESDAY, 7 MARCH 2018

## 1. APOLOGIES

Apologies were received from Councillor Kelly.

Having noted the absence of Councillor Kelly, the Area Committee Manager advised that the Campbeltown Common Good Fund meeting was inquorate and as such was a consultation meeting.

The Area Committee Manager further advised the remaining Ward 1 Members that following a decision made by the Council at the meeting on Thursday 25 June 2015, a delegation had been given to the Executive Director of Customer Services (or his representative) to determine applications in consultation with Ward 1 Members, and the decision recorded are on that basis.

#### 2. DECLARATIONS OF INTEREST

Councillor Colville declared a non-financial interest at item 5(a) South Kintyre Development Trust as he is a Director of the Trust. He left the room and took no part in the discussion of this item.

## 3. MINUTES

## (a) Campbeltown Common Good Fund - 6th December 2017

The Minute of the Campbeltown Common Good Fund held on 6<sup>th</sup> December 2017 was approved as a correct record.

## (b) Special Campbeltown Common Good Fund - 21st December 2017

The Minute of the Special Campbeltown Common Good Fund held on 21<sup>st</sup> December 2017 was approved as a correct record.
