Initiatives for 2015/2016

Around £1.5million of capital investment works

- Maitland Court, Helensburgh, 2 blocks involving roof and roughcast renewal
- Roof and roughcast in Kirkmichael, Helensburgh
- External wall insulation in properties in Arrochar and Rosneath
- Balcony upgrades at Drumfork Court, Helensburgh

Initiatives for 2015/2016 (continued)

- Small programme of completions for kitchen and bathroom renewal
- Heating, rewire, window and door completions in the remaining properties requiring it
- 12 new homes completed at Duchess Court, formerly Hood Court
- Funding secured for 16 new homes in Helensburgh
- New ACHA Offices, Lamont House, Helensburgh
