The applicant has found demand for these services has steadily grown and a more permanent Premises Licence is the best way forward for the family business.

The applicant had consulted with the Licensing Standards Officer and the proposed Operating plan, amended and agreed post submission, as per this report, reflects Board policy in all respects.
