- 3) To add delivery service including delivery of alcohol as an activity.
- 4) To change the wording at Question 5(f) any other activities.

**CURRENT ACTIVITIES:-** Restaurant facilities; Receptions including weddings, funerals etc.; Club or other group meetings; Recorded music; Live performances; outdoor drinking facilities.

**CURRENT DESCRIPTION:-** Glenbarr Stores is a retail village shop, providing groceries, sub post office and convenience store, including off-sales, coffee shop and tea room with outdoor patio area behind shop.

**PROPOSED DESCRIPTION:-** Glenbarr Stores is a retail village shop, providing groceries, sub post office and convenience store, including off-sales, coffee shop and tea room, outdoor patio area behind shop and a delivery of goods service, including alcohol.

**CURRENT WORDING AT QUESTION 5(f) any other activities:-** Provisions of teas, coffees, light snacks and lunches.

**PROPOSED WORDING AT QUESTION 5(f) any other activities:-** Glenbarr Stores Ltd. offers a delivery service of goods including alcohol and tobacco items to the local area to include the campsites and villages without a shop to serve their needs. These items are ordered through the shop and delivered by staff.

**LSO:** This is an application for a major variation to the operating plan to extend on and off sales hours on a permanent basis and to offer a delivery service of goods which will include alcohol.

The applicant has liaised with the LSO during this application and there are no concerns.

Operating Plan - Proposed updates as follows:

Question 2 – On Sales Hours – amend to 1100 hours to 1900 hours (Mon-Sun)

Question 3 – Off Sales Hours – amend to 1100 hours to 1900 hours (Mon-Sun)

Question 5(f) – Additional Activities – include – *“Glenbarr Stores Ltd., offers a delivery service of goods including alcohol and tobacco items to the local area to include campsites and villages without a shop to serve their needs. These items are ordered through the shop and delivered by staff.”*

There are no other changes to the operating plan,

As indicated in the applicant’s covering letter, she is fully aware of Age Verification requirements (*Challenge 25*) and recording procedures in relation to alcohol deliveries. The LSO will monitor and ensure compliance through the licensing standards premises inspection programme.
