DETAILS OF VARIATIONS SOUGHT:-

The applicant wishes to vary the licence as follows:-

- 1) Addition of off-sales to the licence.
- 2) Addition of takeaway meals, including soft drinks, teas and coffees as activities.
- 3) To change the wording at Children and Young Persons conditions.

ADDITION OF OFF SALES:- Off Sales maybe provided on the following restricted basis only:

1. The purchase of rare whiskies.

2. The removal of a partly consumed bottle of wine after a meal giving customers more control over their consumption. This would cover wine purchased with a meal only.

CURRENT CHILDREN AND YOUNG PERSON CONDITIONS:-

TERMS - For a family meal until 8.00pm

AGES - All ages until 8.00pm with a responsible adult.

TIMES - Children and young persons will be allowed entry until 8.00pm with a responsible adult.

PARTS - All seated area with adult

PROPOSED CHILDREN AND YOUNG PERSONS CONDITIONS:-

TERMS - Children and young persons allowed access while accompanied by a person over 18 years or over to take a meal. Unsupervised access allowed when using takeaway food facility.

AGES - Children of all ages (birth to 15 years) and young persons (16 & 17 years).

TIMES - Between 7.00am and 10.00pm.

PARTS - All public parts of the premises.

LSO:- The premises is a restaurant situated in Campbeltown Town Centre. It is a food led business with alcohol as ancillary to meals.

The applicant has liaised with the LSO during the application process and the LSO has no concerns with this application.

Question 3: addition of off sales between 11:00am and 10:00pm daily;

Question 5(f): addition of off sales on a restricted basis and takeaway meals.

Question 6: amendment to children and young person access (including 10:00pm terminal hour) as follows:

Terms

Children and young persons allowed access while accompanied by a responsible person 18 years or over to take a meal. Unsupervised access allowed when using takeaway food facility.

Ages

Children of all ages (birth to 15 years) and young persons (16 & 17 years).

Times

Between 7:00am and 10:00pm.

Parts

All public parts of the premises.

POLICE COMMENTS: No Police objections

OBJECTIONS/REPRESENTATIONS: A letter of objection (received on 12/06/18) has been received from the five tenants who live above the premises. A copy is attached.

POINTS FOR CONSIDERATION:-

- (1) Addition of off-sales but this is to be restricted to the purchase of rare whiskies and taking away a partly consumed bottle of wine purchased with a meal.
- (2) Provision of takeaway meals including teas, coffees and snacks.
- (3) Amendment to the terms for children and young persons:-
 - Extension of the terminal hour from 8pm to 10pm
 - Children and young persons permitted access unsupervised when using takeaway facility
- (4) Consider the letter of objection received from five of the tenants of 14 Longrow South, Campbeltown.
