Area Community Planning Group Governance Arrangements

1. Purpose

1.1 The purpose of this report is to confirm the governance arrangements of the Oban, Lorn & the Isles Area Community Planning Group (Area CPG) specifically the Terms of Reference, membership and future meeting dates.

2. Recommendations

- 2.1 Area CPG members are requested to:
 - Consider and adopt the revised Terms of Reference (TOR) at Appendix 1 which replaces the terms SOA with Local Outcomes Improvement Plans and Localised Delivery Plans with Area Community Action Planning Plans.
 - Agree that the TOR be reviewed on an annual basis to ensure their ongoing currency and appropriateness for the work of the Area CPG as it develops over time.
 - Consider the membership of the group as attached (Appendix 2) and agree any changes which may be required.
 - To agree that the membership of the group be reviewed on an annual basis to ensure currency and appropriateness for the work of the group as it develops over time.
 - To agree the meeting schedule and dates detailed at paragraph 3.3 of this report.

3. Detail

- 3.1 The Area CPG Terms of Reference were last reviewed and agreed in October 2017.
- 3.2 Since the Terms of Reference were agreed, local CPGs have been working hard in overseeing and developing actions within their Area Community Planning Action Plan.

- 3.3 It is expected that the previous process of providing focus for meetings on the actions within Area Community Planning Action Plans will continue, and that effective and timeous reporting of matters to the Community Planning Partnership Management Committee will continue. To that effect members are asked to agree that the meeting dates for the Oban, Lorn & the Isles Area CPG will be:
 - Wednesday 8th May 2019, 2pm, Corran Halls, Oban Wednesday 14th August 2019, 6.30pm, Corran Halls, Oban
 - Wednesday 13th November 2019, 2pm, Corran Halls, Oban
 - Wednesday 12th February 2020, 6.30pm, Corran Halls, Oban
 - Wednesday 13th May 2020, 2pm, Corran Halls, Oban
- 3.4 The membership of the Area CPG was also last reviewed in October 2017 and has experienced some changes over that time. The Area CPG are asked to consider whether any additional changes should be made to the suggested revised membership outlined within Appendix 2
- 3.5 A formal review of the membership will be carried out on an annual basis to ensure currency and appropriateness for the work of the group as it develops over time.
- 3.6 It should be noted that membership will continue to be reviewed on a regular basis by the Area CPG and that there is provision for additional organisations to join the group at a later date to accommodate local circumstances.
