#### **DESCRIPTION OF PREMISES:**

Caol Ila Distillery is situated on the coast some two miles from the ferry terminal of Port Askaig, Isle of Islay. Caol Ila Distillery is a working distillery and welcomes visitors. The distillery complex basically comprises two buildings, separate but close to each other. One is an office block and one mainly comprises the actual distillery process building. Both buildings are on two levels. On the ground floor of the office building, is a room that has in the past been used as a sales outlet. On the ground floor of the main building is an area that currently serves as the site sales shop.

## **DETAILS OF VARIATIONS SOUGHT:-**

The applicants wish to vary the licence as follows:-

- 1) To include on-sales Monday to Sunday 10.00 23.00.
- 2) To amend off-sales hours to Monday to Sunday 10.00 22.00.
- 3) To amend the seasonal variation.
- 4) To include conference facilities, restaurant facilities, receptions, club or other meetings, recorded music, live performances, dance, theatre, film and outdoor drinking as activities.
- 5) To amend the wording at Question 5(f) Any other activities.
- 6) Insertion of wording relating to children and young persons.
- 7) To include on sales capacity and increase off-sales capacity.
- 8) Change to the layout of the premises.
- 9) Change to the description of the premises.

**CURRENT SEASONAL VARIATION:-** Although no application is made for seasonal variation, the premises would like to exercise the right not to open the facility when there is no demand.

**PROPOSED SEASONAL VARIATION:-** The premises may close outwith the times stated in light of customer demand or weather conditions.

**ACTIVITIES:-** There are currently no activities noted on the operating plan. The licence holders wish to add conference facilities; restaurant facilities; receptions; club or other group meetings; recorded music; live performances; dance; theatre; film and outdoor drinking.

#### PROPOSED CHILDREN & YOUNG PERSON'S CONDITIONS:-

TERMS - Children may be permitted access on the premises if accompanied by an adult. Young persons may be permitted access unaccompanied.

AGES - All ages of children and young persons may be permitted on the premises.

TIMES - At all times the premises are open.

PARTS - Children and young persons may be permitted on all public parts of the premises.

**ALCOHOL DISPLAY AREA:-** Proposed off sales – 25.25m2. Proposed On sales – 232 persons with 1000 for special events/festivals.

**CURRENT DESCRIPTION OF PREMISES:-** Caol Ila Distillery is situated on the coast some two miles from the ferry terminal of Port Askaig, Isle of Islay. Caol Ila Dislillery is a working distillery and welcomes visitors. The distillery complex basically comprises two buildings, seperate but close to each other. On the ground floor of the office building, is a room that has in the past been used as a sales outlet. **PROPOSED DESCRIPTION OF PREMISES:-** Caol Ila Distillery is situated on the coast some two miles from the ferry terminal of Port Askaig, Isle of Islay. Part of a whisky distillery, the licensed areas include a shop, office/reception building, cooperage and external licensed areas.

**LSO:-** This is a major variation to update several aspects of premises operation. The premises will be updated to include On-Sales and Visitor Centre. The licensing standards officer has no concerns with this application.

# **Description of Premises**

Update of other activities, including -

Outdoor Drinking - the Board may wish to include in this section the standard terminal hour for the use of this facility as —

"The terminal hour for the external drinking area is 10:00pm for adults aged 18 years and over and 8:00pm for children and young persons."

# Question 6

Addition of Children and Young Persons access.

Under the 'Terms' section the Board may consider revising the wording to include "...adult aged 18 years or over."

Under 'Times' section the Board may consider adding the standard terminal hour for the outdoor drinking area; "The terminal hour for the external drinking area is 10:00pm for adults aged 18 years and over and 8:00pm for children and young persons."

## Question 7

Amend capacity to -

Off-Sales -25.25m<sup>2</sup>.

On-Sales – 232 with 1000 for special events/festivals.

N.B. Visitor Centres and premises where alcohol is produced are exempt from the requirements of Licensing Condition 13 with regards to display of alcohol in specific areas.
