- 2) Change in capacity to reflect additional external areas and upstairs in Malt Mill and to cover special events/festivals.
- 3) Inclusion of wording in 5(f) to cover use in Islay Festivals.
- 4) To change the layout plan of the premises.

ITEM 5(d)

CAPACITY OF PREMISES:- The current capacity of the premises is 479. This is to be increased to 526 with a capacity of 1500 for special events/festivals.

LAYOUT:- The layout is to be amended to include the upper floor of the malt mill and inclusion of external areas. Also reconfiguring licensed area for Visitor Centre.

LSO:- This major variation proposes updates to the operating plan to allow bar meals both within and outwith core hours; change in capacity to reflect external areas and upstairs in the Malt Mill and to cover special events/festivals; and to include the wording at Question 5(f) –

"The premises may be used as a venue for the Islay Festivals."

The layout plan will also be updated to reflect the inclusion of upper floor of the Malt Mill; inclusion of external area; and reconfiguration of licensed area/drawings for Visitor Centre.

The licensing standards officer has no concerns with this application.
