### **DESCRIPTION OF PREMISES:**

The proposal is for the development of a "Premier Inn" branded hotel with some 80 bedrooms with hotel reception and restaurant, bar and associated facilities at ground floor level. The site and ground floor layout is identified on the deposited drawings with, in general terms, ground floor entrance lobby. Hotel reception, food and beverage facilities typical for a development of this type.

The bedrooms will be situated on the remainder of the ground floor and on the upper floors comprising in all some 80 bedrooms.

It is intended the hotel residents should be entitled to consume alcohol purchased from the bar in their hotel bedrooms and such bedrooms are included within the ambit of the licence for this purpose only.
