Thank you for your email of 2nd April. I have three observations:

- 1 Representation: in the section 'COMMENTS ON THE APPELLANT'S SUBMISSION', paragraph 3, line 4, where it quotes an extract of the applicant's submission, it should read: '...permanent feature of the asset', rather than '...of the assess';
- 2 The Lismore Community Trust directors, notwithstanding the Appeal, have met with James Jackson of the Council's Roads Department, and have undertaken some site investigation, and submitted the results, plus a proposed layout plan. Mr Jackson considers the layout satisfactory, and has advised on a specification of materials. A copy of this correspondence will be forwarded for your attention shortly. In this way, the directors show that they are taking their responsibilities seriously in the best interests of their community. The difficulty remains, however, of how to raise sufficient funds for a significant permanent asset improvement, given that it will revert to the Council in due course, and potentially at any time with a Notice period of only 6 weeks.
- 3 If the Council were in a position to assist the implementation of the work required, the directors would be in a much stronger position to advance these evident improvements.
