Question 6 (On Sales only)

Children and Young Persons

There is a requirement to post a sign on front entrances indicating children access; terms, times, ages, and places so this must be specific, below is wording which falls with Board Policy which may suit your needs. Bearing in mind this is more than a cinema and is also a museum.

Terms

Children will be permitted access to the premises when accompanied by an adult over the age of 18 years. Young Persons will be permitted access to the premises.

Ages

Children 0-15 years Young Persons 16 & 17 years

Times

Children and Young Persons will be permitted access until 10pm unless attending a prebooked function or event and may then remain for the duration.

Parts

Children and Young Persons will be permitted access to all public areas, with the exception of the immediate vicinity of any alcohol bar counter.
