DETAILS OF VARIATIONS SOUGHT:-

The applicant wishes to vary the licence as follows:-

1) A seasonal variation is to be added restricting opening hours during the period between 1st October and 1st April.

2) The capacity figure shall be amended to 150 persons.

PROPOSED SEASONAL VARIATION:- The premises may open one hour after the commencement of core hours Monday to Sunday and may close one hour before the terminal hour on Monday, Tuesday and Wednesday between 1st October and 1st April.

Current Capacity: On Sales – 78 persons Proposed Capacity: On Sales – 150 persons

LSO:- This application is to add a Seasonal Variation at Question 4 of the premises licence operating plan and augment the capacity of the premises at Question 7.

Question 4 - Seasonal Variation

"The premises may open one hour after the commencement of core hours, Monday to Sunday, and may close one hour before the terminal hour on Monday, Tuesday, and Wednesday, between 1st October and 1st April."

Question 7 – Capacity

Amend from 78 persons to 150 persons.

The applicant has provided an e-mail from DPD Fire and Safety Consultants alluding to a Fire Risk Assessment of the premises carried out by this company advising that capacity could be raised from the current 78 persons to 150 persons. At the time of submitting this report there has been no report from Building Standards or Scottish Fire and Rescue.

Scottish Government guidance to licensing boards is clear that the capacity of licensed premises providing on sales of alcohol is recorded on the premises licence operating solely as an indication in calculating overprovision of premises in the area in which the premises is located:

"...61. The recommendation of the National Licensing Forum, agreed by Ministers, is that, for the purposes of the overprovision assessment, the operating capacity of licensed premises should be determined by local authority building standards officers. Any operating capacity figure that is determined should only be used for the purposes of overprovision under the Licensing (Scotland) Act 2005 and for no other purposes. The definition of operating capacity for on-sales and off-sales is set out in section 147 of the Act. Based on these definitions the proposed methodology for calculating capacity for on-sales and off-sales is set out below.

Off-sales

- the maximum linear measurement, in metres, of the frontage used to display alcohol, including the areas utilised for off-shelf seasonal or any other promotional displays.

On-sales

- The Buildings (Scotland) Regulations 2004 assessment methods set out in the Technical Handbooks issued in support of these regulations."

If the Board is minded to grant this aspect of the application the LSO recommends confirmation of suitability from Building Standards.
