#### POINTS FOR CONSIDERATION:-

- (1) Awaiting receipt of the section 50 Planning Certificate.
- (2) The applicant has provided a number of photographs of the interior of the premises (enclosed).
- (3) There is to be no bar on the premises. The agent has advised that there will be two wooden cabinets located in the reception area, one containing alcohol and the other glasses. See attached e-mail dated 2<sup>nd</sup> September together with two photographs.
- (4) The agent has confirmed that there will be no hot tubs.
- (5) There will be no outdoor sports. The indoor sports are limited to the provision of a gym which will be available for use by residents.
- (6) Any music/live performances will be limited to acoustic e.g. someone playing a guitar
- (7) Consider the terms of the seven objections.
