The first floor accommodates 22 bedrooms as well as offices and sitting room. The second floor accommodates 14 bedrooms including owners accommodation.

The locality - The hotel is situated on the main street in Inveraray within a mixture of residential dwellings and retail premises.

"The terminal hour for the use of the outdoor area will be 10:00pm for persons aged 18 years and over and 8:00pm for children and young persons of all ages."

Question 6(d) & (e): Children and Young Persons Access (Times & Parts)

The applicant has already added the Board policy curfew times for outdoor drinking:

"Children and young persons of all ages will be allowed access to the outdoor drinking area when accompanied by a person aged 18 years or over and until 8:00pm."

Question 7: Capacity

Add 50 persons for outdoor area.

Layout Plan

Add outdoor drinking to the layout plan.

The layout plan submitted shows the outdoor area in yellow. This area is not scaled. It is recommended that the applicant submit an updated plan showing the yellow area bounded in red and suitably scaled (i.e. 1:100 or 1:50) as required by
