**DESCRIPTION OF PREMISES:**

The Glass Barn Café will be solely occupied and run primarily as a café/restaurant.

The Café is situated on Sgriob-ruadh Farm in a rural setting where Isle of Mull Cheese is produced.

Customers will have the opportunity to eat in or take away, including both food and beverage.

Customers will also be able to take part in tours of the farm and both sample and purchase the cheese and spirits produced on the premises.

TIMES - Children and young persons will be allowed entry between 10am and 10pm Sunday to Thursday, 10am to 12am Friday and Saturday.
