# 3. MINUTES

#### 4. BUDGET MONITORING - 10 MONTHS TO 31 JANUARY 2022

The Committee gave consideration to a report which provided a summary of the financial position of the Health and Social Care Partnership for the 10 months to 31 January 2022 and an updated financial forecast for the year. The report also provided an update on the savings programme and additional in-year funding allocation to help manage winter pressures.

## **Decision**

The Finance and Policy Committee –

- 1. Welcomed the Month 10 forecast and noted that the outturn position is an underspend of £122k.
- 2. Noted that it is anticipated that unspent funds will be carried forward as earmarked reserves and that the JB expects to repay debt owed to Argyll and Bute Council early.
- 3. Noted that there is a year to date underspend of £357k at 31 January 2022.
