- 5) Add Children and Young Persons conditions.
- 6) Change to the layout plan.
- 7) To amend the description of the premises.

CURRENT ACTIVITIES: Recorded music

PROPOSED CHILDREN AND YOUNG PERSONS CONDITIONS:-

TERMS - Children and young persons are allowed access in the company of a responsible person aged 18 years or over for the purpose of taking a snack.

AGES - Children (birth to 15 years) and Young Persons (16 & 17 years).

TIMES - During core licensing hours.

PARTS - All public parts of the premises.

LSO: (Eric Dearie)

The premises is already an established specialist gin outlet providing off sales of alcohol. This application is to vary the premises licence to include on sales of alcohol and outdoor drinking.

Description of Premises

To update the premises description on the first page of the premises licence from -

"The premises are a specialist off-sales outlet. The shop is situated inside Islay Square."

Question 3 (Off Sales) - amend to 1000 to 1700 (Mon-Sat) and 1200 to 1600 (Sun).

Question 5 – Allowable Activities

Add films within core licensing hours.

ITEM 6(b)

Add outdoor drinking. As the premises will be open no later than 1700 hours, Board policy on outdoor drinking curfews does not apply.

Question 5(f) – Additional Activities

Include the statement "Light snacks (e.g. crisps) may be available."

Question 6 – Children and Young Person Access

As there is a proposal for on sales, the LSO and applicant have agreed a Children & Young Persons Access Statement as follows for the Board's approval –

Terms

Children and young persons are allowed access in the company of a responsible person aged 18 years or over for the purpose of taking a snack.

Ages

Children [birth to 15 years] and young persons [16 & 17 years].

During core licensing hours.

Parts

All public parts of the premises.
