DESCRIPTION OF PREMISES:

Visitor attraction comprising a museum and castle ruin, set within historic grounds and open to the public seasonally (April - October) with special events taking place during the winter (November - March). The premises licence is required for the outdoor areas only.

ACTIVITIES:- Conference facilities; Restaurant facilities; Receptions including weddings, funerals etc.; Club or other group meetings; Recorded music; Live performances; Dance facilities; Theatre; Films and outdoor drinking facilities.

SEASONAL VARIATION:- Dunollie Museum, Castle and Grounds is open seasonally to the public (April - October). During peak season, we expect to be running 2-4 external hire events with alcohol

being served, and 8-10 in-house events. During the off-peak season we would expect this to be less, for example 1-2 external hires, and 2-4 in-house events per month.

Off-sales during the off peak season would be restricted to event days. During the peak season, off-sales would be during site opening hours, currently Sunday to Friday 11am to 4pm, but this may increase to 7 days and longer opening hours from 2023.

CHILDREN AND YOUNG PERSONS CONDITIONS:-

TERMS – Children aged 0+ and young persons aged 16 and 17 allowed entry only with an accompanying adult aged 18 or over, between the hours of 11am and 11pm.

AGES – Children of all ages. 0+ and young persons aged 16 and 17.

TIMES – Children and young persons will be allowed entry between 11am - 11pm.

PARTS - Children and young persons will be allowed entry in all public areas of the site, with the exception of any immediate bar vicinity.

CAPACITY OF PREMISES:- 100 persons outside
