DESCRIPTION OF PREMISES:

The Blairmore is a ground floor cafe open up to 7 days a week, providing light meals, home-baking, speciality teas and coffees. There are tables and chairs at the front of the building for some outside seating.

There will be no dedicated bar area.

The Blairmore is located in the small, rural, coastal village of Blairmore and is part of the original shops of the village. It is part of a building with a further retail premises and holiday let on the ground floor. Above the cafe is a flat which is currently being converted into a holiday let.

The applicant wishes to vary the licence as follows:-

- 1) To change the terminal time for core hours on-sales to 22.30 on all days.
- 2) To change the terminal time for core hours off-sales to 22.00 on all days.
- 3) To change the terminal time for children and young persons to 22.30 on all days.
- 4) To amend the seasonal variation.

CURRENT CHILDREN AND YOUNG PERSON'S CONDITIONS:

TIMES - Children and young persons will be allowed entry during our stated opening hours. - 9.30am to 6.00pm.

PROPOSED CHILDREN AND YOUNG PERSON'S CONDITIONS:

TIMES - Children and young persons will be allowed entry during our stated opening hours. - 9.30am to 10.30pm.

CURRENT SEASONAL VARIATION:

The times are for the high season period (April to October). It is envisaged that winter opening hours will be reduced. We plan to offer a Christmas Menu and are exploring the possibility of occasional evening functions which would all be pre-booked and pending grant of extended hours applications.

PROPOSED SEASONAL VARIATION:

High Season, April to October. Low Season, November to March (approximately).

The additional core hours from 18.00 to 22.30 are applicable due to customer request and seasonal demand for occasional evening dining, particularly during the high and festive season periods. As demand decreases, it is envisaged that low season hours will be reduced.

LSO: The applicant has re-visited her Operating Plan and in line with customer demand wishes to introduce evening dining which requires a variation to the current core and child access times. The applicant has identified this additional service as more seasonal, as such a new seasonal variation is applicable.
