## 2.0 INTRODUCTION

- 2.1 This report provides details of all external education establishment inspection reports received across Argyll and Bute Education Service during the period November 2022 to January 2023.
- 2.2 As required for the National Improvement Framework, HMIE report on and provide grades for the following Quality Indicators (Qls) as part of full model inspections (which typically take place over a full school week):
  - QI 1.3 leadership of change;
  - QI 2.3 learning, teaching and assessment;
  - QI 3.1 ensuring wellbeing, equality and inclusion; and
  - QI 3.2 raising attainment and achievement

In addition they include a focus on the following themes from other Qls:

- QI 2.2 curriculum: learning pathways
- QI 2.7 partnerships: parental engagement
- 2.3 Short model inspections (typically over two and a half days) focus on two Qls:
  - QI 2.3 learning, teaching and assessment; and
  - QI 3.2 raising attainment and achievement

HMIE continue to have a focus on safeguarding in every inspection.

2.4 In inspections of early learning and childcare settings, HMIE use the equivalent Qls from 'How Good Is Our Early Learning and Childcare?'

## 4.0 DETAIL - School Inspections

4.1 Furnace Primary School was inspected week beginning 31<sup>st</sup> October using the short model inspection.

4.2 Dalmally Primary School and ELC was inspected week beginning 5<sup>th</sup> December using the long model inspection. The school received very positive feedback from the Managing Inspector with specific reference to the effective teamwork across the school and ELC which creates a nurturing and caring environment for all children, effective planning in the ELC to meet children's individual needs and effective planning in school to support learning and teaching in the multi-composite classes. 4.3 Lochdonhead Primary School was inspected week beginning 9<sup>th</sup> January using the long model inspection. The school received very positive feedback from the Managing Inspector with specific reference to the compassionate, articulate, independent children who display an enthusiasm for learning, the highly effective leadership and direction of the headteacher and principal teacher, very high quality teaching and learning provision and, the very well-established, high-quality community and partnership working and its significant impact. 4.4 Islay High School was inspected week beginning 16<sup>th</sup> January using the long model inspection. The school received very positive feedback from the Managing Inspector with specific reference to; senior leaders and staff working well together to develop a caring ethos where young people feel valued and included; the range of useful, individualised feedback young people receive particularly from S3 to S6 which helps them attain well in National Qualifications by the end of S6; the student support team which is highly effective in planning and reviewing young people's wellbeing needs. As a result young people who require additional support feel included and achieve success in their learning; and, the young people who are keen to learn through Gaelic in a range of situations, achieved through the use of technologies and established partners in the community.

- 4.5 Kilmartin Primary School was inspected week beginning 30th January using the short model of inspection. The school received positive feedback from the Managing Inspector with specific reference to the friendly children across the ELC and school who are keen to learn and, the supportive way that the headteacher, school staff, partners and the wider community work together to enrich the curriculum through a variety of experiences. - 4.6 Education Scotland visited St Andrew's Primary School in November 2019 and, following the visit, published a letter in February 2020 outlining the school's key strengths and areas for improvement. They published a further update of the school's progress in December 2021 and requested Argyll and Bute Council provide them with a progress report in December 2022.

Following receipt of Argyll and Bute's progress report and an associated review meeting, Education Scotland have acknowledged the school's progress and expressed confidence in its capacity to continue to improve. Consequently they will not publish any further reports or make any additional visits in relation to the original inspection visit.

## 5.0 DETAIL - National Thematic Inspections

- 5.1 In addition to visits to schools and settings, HMIE will also be carrying out national thematic inspections in the academic year 2022-2023.
- 5.2 The next phase of the national thematic inspection will focus on curriculum design. HMIE will visit a selection of around 50 settings and schools between 27<sup>th</sup> February and 23<sup>rd</sup> June 2023. This will enable them to publish their findings in the format of a national report in the autumn of 2023. The selection of settings and schools will include a geographical spread across Scotland and include Early Learning and Childcare, primary, secondary and special schools.
- 5.3 Visits to settings and schools will last between one and two days depending on the size of the establishment. At the end of the visit, the lead inspector will provide verbal feedback to the headteacher.

Overall findings will be shared through a national report. The link to the published report will be accessible when it is available on Education Scotland's website.

## 6.0 CONCLUSION

- 6.1 In summary, one published report is available for the Inspections which took place during the period of November 2022 to January 2023.
- 6.2 The Education Service will continue to use the outcomes of establishment inspections to work collaboratively with our Headteachers to target support and challenge to secure improvement for our children and young people.

# **Key Findings:**

The inspection team found the following **strengths** in the school's work.

- Children who are polite, welcoming and keen to contribute. They engage well in the calm and inclusive ethos within school and are proud of sharing their learning, along with their local knowledge and interests.
- Strong leadership provided by the acting headteacher and staff team. The staff team understand the uniqueness of Furnace Primary and are addressing individual needs well. They know the strengths and areas for development well across the school, with clear plans in place for continued improvements.
- The use of digital technologies by children and staff to enrich learning experiences, including through remote learning activities.

The following areas for improvement were identified and discussed with the headteacher and a representative from Argyll and Bute Council.

- Improve children's attainment across the curriculum, particularly in writing.
- Continue to work together closely with parents/carers to support children to achieve maximum success.
- Continue to enhance opportunities for social interaction with larger groups of children, through working in partnership with the linked school and others.

# **Key Findings:**

The inspection team found the following **strengths** in the school's work.

- The effective team of staff across the pre five unit and school. Together they ensure all children learn in a caring and nurturing environment. Respectful relationships are evident across the school community.
- Effective planning in the pre five unit. This ensures children's individual needs are met.
- The effective approaches teachers use to plan learning that meets the needs of all children in multicomposite classes.

The following **areas for improvement** were identified and discussed with the headteacher and a representative from Argyll and Bute Council.

- Increase the pace of change across the school. Ensure improvement priorities are ambitious and lead to improved outcomes for learners.
- Continue to develop the curriculum to ensure children experience progression, breadth and depth in their learning.
- Continue to raise attainment in literacy and numeracy with a strong focus on accelerating progress to close the poverty related attainment gap.
