1. APOLOGIES FOR ABSENCE

Apologies for absence were intimated on behalf of Graham Bell and Fiona Broderick.

2. DECLARATIONS OF INTEREST

There were no declarations of interest intimated.

3. MINUTES

The Minute of the meeting of the Finance and Policy Committee, held on 25 November 2022 was approved as a correct record.

4. BUDGET MONITORING - 9 MONTHS TO 31 DECEMBER 2022

The Committee gave consideration to a report providing a summary of the financial position of the Health and Social Care Partnership as at 31 December 2022. The report also provided a forecast for the year and an update on the delivery of savings programme and the use of reserves.

Decision

The Finance and Policy Committee -

- 1. Noted that there is a relatively small forecast revenue overspend of £598k as at 31 December 2022 and that it is anticipated that the HSCP will operate within available resources.
- 2. Noted confirmation that savings of £3.6m have been delivered, 60% of target.
- 3. Noted that earmarked reserves of £6.2m have been committed to date.
- 4. Noted that the Scottish Government have confirmed the clawback of £3.6m in covid reserves and have reduced Primary Care Improvement allocations by £2.8m as a consequence of reserves held.

5. BUDGET AND MEDIUM TERM FINANCIAL PLAN 2023-2026

Consideration was given to a report which provided the updated budget outlook for the 2023/24 financial year and medium term financial plan. The report included additional detail in respect of initial savings proposals aimed at balancing the position with a view to enabling the JB to consider and approve a balanced budget at its meeting in March 2023.

Decision

The Finance and Policy Committee -

- 1. Considered the Financial Plan and budget outlook for 2023-24 to 2025-26 and noted the high level of risk and uncertainty.
- 2. Noted the forecast budget gap totalling £9.4m.
- 3. Noted that indicative savings targets have been allocated to services.
- 4. Noted the progress to date in identifying proposals to address the budget gap.

- 5. Noted that the Head of Finance and Transformation would provide an updated timeline in terms of future savings to the next meeting of the Finance and Policy Committee.
- 6. Noted the ongoing work in relation to the Communication Engagement Strategy and that the Business Improvement Manager would provide a progress update to the next meeting of the Finance and Policy Committee.

6. FINANCIAL RISKS 2022-23

Consideration was given to a report which provided an update on the perceived financial risks facing the HSCP, which could have an impact upon financial performance during the remainder of 2022/23.

Decision

- 1. Considered the 2022/23 financial risks identified for the HSCP as at 31 December 2022 and noted the mitigations.
- 2. Noted that several previously highlighted risks are now resolved, including the clawback of reserves.
- 3. Noted that this is the last financial risks report for 2022/23 as the year is close to ending and that risks will be included in forecasts where appropriate.

- 2. Noted the actions planned to support service delivery and progress of the Unscheduled Care Programme within Argyll and Bute.
