#### Title of Proposal

Review of Individual Sleepover Provision with increased utilisation of available TEC

#### Intended outcome of proposal

- Maximise independence of service users and support them to live fulfilling lives in their own homes, for as long as possible
- Future proofing available resources within the locality, utilising available TEC to in order to minimise the requirement for additional care staffing
- Financial savings of approx. £80k

#### Description of proposal

This proposal is part of the ongoing review of existing individual sleepover provision across A&B, looking at opportunities for shared overnight support or removal of individual sleepover provision where it is no longer considered necessary following appropriate risk assessment and implementation of supporting TEC/responder service.

Care Management Team's will assess and review existing care packages as part of the Assessment and Care Management process, to ensure that the current provision continues to maximise independence for service users and support them to live fulfilling lives in their own homes, for as long as possible.

Additionally, this will free up much needed staffing resources within the locality to meet current staffing issues and demand for services. In particular this staffing resource may support the repatriation of 2 service users back to the area from their current out of area residential care placements.
