- Endorse the joint plan for 2023-26 which succeeds the previous plan. This will be reported on annually to partners.

1. EXECUTIVE SUMMARY

The Argyll and Bute 2023–2026 Children and Young People's Service Plan builds on earlier plans and was developed by listening to and understanding the needs of our children, young people, and their families. This plan continues our focus on promoting children and young people's wellbeing, underpinned by Getting it Right for Every Child (GIRFEC), and extends this by developing our trauma informed workforce.

Through this we are ensuring we embed UNCRC (United Nations Convention on the Rights of the Child) and The Promise at the core of everything we do. This links across several other plans including the Local Outcome Improvement Plan (LOIP).

The Joint Strategic Needs Assessment provides the foundation for this work, underpins the Children and Young People's Service Plan and the Corporate Parenting and Child Protection Plans.

The plan is developed in partnership including our most important partners; children and young people and sets out the joint vision, priorities and outcomes for Argyll & Bute's.

2. INTRODUCTION

The Argyll and Bute Children's Services Partnership are legally required under S15 of the Children & Young People's (Scotland) Act 2014 to publish a Children Services Plan every three years. The three year cycles started on 1st April 2014, thus the current plan runs from 1st April 2023 to 31st March 2026.

The plan succeeds the previous Children and Young Peoples Service plan.

3. DETAIL OF REPORT

The plan is underpinned by Getting it Right for Every Child, UNCRC (United Nations Convention on the Rights of the Child) and The Promise.

We have fully committed to The Promise made to Scotland's infants, children, young people, adults, and families. By 2030, we will transform our care system and the values around which it operates. Ensuring we uphold safe, loving relationships that are important to children and young people and that we continue the transformation of our community services to make sure more children are supported to stay safely with their families. Integral to this plan is building upon and embedding our commitment to the priorities and values of **The Promise**.

The four values outlined are ensuring that Children have a **Voice** and are listened to meaningfully and involved in decisions about their care. **Family** and **Care** support to ensure that young people are in a safe nurturing environment and where that is not possible with their family that they have the opportunity to belong in a safe home staying there for as long as is needed.

The promise wants children to be actively cared for by **People** in the wider workforce and community who in turn must be supported to listen and be compassionate in their decision making and care.

The **Scaffolding** that is required to help this system be sustainable and effective, accountable, ready and responsive.

This plan provides a framework for partnership professionals, parents, carers, and volunteers to work with our children and young people, helping to shape and improve the services we offer.

The partnership is fully committed to continuing to deliver our Children and Young People's Service Plan. We thank all contributors to the plan for their ongoing support and commitment to working together and achieving the best possible outcomes for young people.

Argyll and Bute's vision commits partners to "work together to achieve the best for children, young people, and families." To realise this vision, this Children and Young People's Service Plan is underpinned by the Getting It Right for Every Child (GIRFEC) framework. The strategic priorities also align with Outcome 4 in the local Single Outcome Agreement (SOA) and the National Performance Framework (NPF)

4. RELEVANT DATA AND INDICATORS

The report utilised the Joint Needs Assessment and subsequent co-production with children, young people and partners.

5. CONTRIBUTION TO STRATEGIC PRIORITIES

This plan supports the Strategic Priorities of the Integration Joint Board. The rights of the child and The Promise involve supporting a positive environment including families and also supporting workforce in their capacity to support children. This is consistent with IJB priorities.
