DETAILS OF VARIATIONS SOUGHT:-

The applicant wishes to vary the licence as follows:-

- 1) To change the start time on a Sunday for on and off sales from 12.30pm to 11.00am.
- 2) Add restaurant as an activity and change column 4 to Yes for activities related to early opening for breakfast.
- 3) Amend the Children and Young Person Conditions.

4) To remove reference to 'restricted family area' on layout plan.

CURRENT ACTIVITIES: Bar meals; Celebrations; Funerals; Club or other group meetings; Recorded music; Live performances; Dance; Gaming; Indoor/Outdoor sports and televised sports.

CURRENT CHILDREN AND YOUNG PERSONS CONDITIONS:-

TERMS – Children with adults will be seated in the designated family area 0-17 yrs. 14 - 17 yrs will be allowed to sit in the eating area with adults - they will be allowed to play pool. No children or young persons will be allowed to approach the bar or be served alcohol.

AGES – 0-17 years

TIMES – Children from 0-17 years will be permitted access from 11.00am to 8.00pm Monday to Saturday and 12.30pm to 8.00pm on a Sunday

PARTS – Family eating area, restaurant and pool area. Not allowed to approach the bar.

PROPOSED CHILDREN AND YOUNG PERSONS CONDITIONS:-

TERMS – Children will be permitted access provided they are accompanied by an adult 18 years or over. Young persons will be permitted access for the consumption of food.

AGES – Children 0-15 years; Young persons 16-17 years

TIMES – Children and young persons will be permitted access until 22.00 hours and may remain for the duration of a function or event.

PARTS - All public areas with the exception of immediate bar serverly area.
