CRUACH MHOR WIND FARM TRUST REPORT FOR YEAR TO $31^{\rm ST}$ MARCH 2010

This report is made to the Bute and Cowal area committee of Argyll and Bute Council of the activities of the Cruach Mhor Wind Farm Trust for the year ending 31st March 2010. At the year end the Trustees in office were Councillor Alex McNaughton, elected member and chairman, Councillor Bruce Marshall, Danuta Steedman and Tom Mowat nominees of the Colintraive and Glendaruel Community Council and Martin Mather a representative of Scottish Power.

The annual index linked payment from Scottish Power for the year was £ 24,665.37. Interest from invested funds and on the ordinary trustees account with the Royal Bank of Scotland had dropped considerably.

During the year eighteen applications had been received for grants totalling £27,829.17 as listed on the attached statement of account. Eight of these had been approved for sporting and musical activities of the local children. The year included a grant to the local Shinty Club of £ 9,496.13 to purchase a better pavilion as well as the first payment in support of the local Development Trust of £ 7,161.54. The Wind Farm Trust had approved a grant of £42,000 in support of the Development Trust to be spread over two years.

At the close of the period the funds shown in the attached statement stood at £66,203.92. With interest rates currently so low, more would be invested in the Deposited Funds with the Royal Bank of Scotland only when they improved.
