Dear Mr Reppke,

I refer to your letter dated 01 November 2011 concerning review of taxi fare scales and my reply of 6th November 2011. I understand from the local press (Oban Times) that a meeting has been held where it was decided to freeze taxi fares at their present level and review the situation in 18 months.

I can understand the freeze on current taxi fares. I and other taxi drivers have to make a living and an increase in fares might deter people from using taxis when we are all having to tighten our belts. However, I feel 18 months is too long a time to wait for a review. A review by the Council in, say, 6 or 9 months is not a commitment to an increase – just a commitment to a review. I feel taxi owners/operators/drivers would welcome a shorter timescale to the next review.

I do not know if you intend to reply to my letter of 6th November in light of your meeting – in particular, my point about taxis in remote/island areas being allowed to operate on tarrif 2 as their base rate. I feel this suggestion has some merit and I would like to know how it was received at your meeting.

I am an owner operator taxi driver working under the umbrella of an existing taxi company in Oban.

I am writing to express my concern at article in the Oban Times, which stated that the taxi tariff in Oban would be frozen until 2013.

At present as everyone is aware money is tight and as a consequence drivers are being asked to forgo an increase in fares until 2013 as outlined in the article.

I would suggest that instead of increasing the base tariff, the Council should decrease the yardage. At present with a 20p increase on the basic tariff, the cost of taking a client to Glasgow Airport would only be increased by 20p. However, if a decrease on the yardage were introduced it would mean the drivers would get a better return per journey.

As we are all aware the Government will no doubt increase the price of fuel at least once if not more than once in the 18 month period before the next review of taxi fares, consequently, I therefore state that I oppose the freezing of taxi fares in Oban.

Dear Argyll and Bute Council,

I am writing as Chairman of the Taxi Owners

and Drivers Association of Dunoon.

The Association has asked me to write a letter of appeal and objection to the council's recent decision to deny the Taxis a fare increase and to extend the next application time to 18month.

The council awarded the Taxis a fare increase of 20p on the flag drop last year which has meant that pensioners and families taking short journeys home with shopping have seen an increase of 8% in their fares but those that take longer journeys, therefore using more fuel, have seen an increase of 1% or less in their fare.

The last true fare increase on the rolling mile was given in 2009. At that time the cost of fuel in March was, Diesel 100.1 per litre; Petrol 96.1 per litre and in December 2009 Diesel 110.2 per litre; Petrol 107.6 per litre. (Figures from the AA fuel report 2000 to 2010.) As the Council will be aware fuel prices in Dunoon tend to be marginally higher than the national average and presently, are diesel 142.9 per litre and petrol 138.9 per litre. This is a 42% increase in fuel prices since the last fare rise. Given that it could be a further 2 years before the next fare increase is enacted that would see a predicted price of Diesel 170 per litre and Petrol at 156 per litre, which would start to make life as a taxi owner/operator become unsustainable. Fuel is the single largest bill that taxi owners have to deal with and we feel we are not being greedy or excessive in asking for the 'rolling mile' to rise to £2.00 per mile and we would ask the flag drop distance to increase to 880yds.

We, in Dunoon, understand that Helensburgh is anxious not to have an increase as they have competition from the surrounding towns and cities. Dunoon, Oban, Campbeltown and other Argyll villages and towns do not have those issues and are paying prime rates for fuel. Helensburgh should be considered separately when dealing with fare increases as it feels that appearing one city will punish the rest of Argyll and Bute Taxis.

This fare increase is needed by us to cover the ever increasing cost of fuel and not to improve but just to maintain our present standard of living.

I have enclosed signed sheets from association members in agreement with this letter.
