#### **Development actions from SOA QA Panel**

#### 1 SUMMARY

1.1 This report updates the Management Committee on the progress to date following the Single Outcome Agreement Quality Assurance process in June 2013. The appendix to the report sets out the specific actions and timeline that are summarised in the previous Progress Report paper.

#### 2 RECOMMENDATION

- 2.1 1 That the Management Committee notes the content of the report and the attached table showing progress against each area for improvement.
  - That the Management Committee recognises that there is a significant amount of work required to ensure that the SOA is developed fully and robustly and that partners commit to ensuring that resources are committed to enabling this process.

#### 3 DETAIL

- 3.1 The Scottish Government's Single Outcome Agreement Quality Assurance Team along with representatives from Argyll and Bute CPP agreed a number of development priorities for the SOA 2013-23. These have been summarised in the Progress report paper. This paper presents a detailed update in the attached appendix on the progress towards achieving the improvement plan targets.

- 3.3 In order to ensure that the SOA is completed, there is a requirement for a full commitment from all partners in terms of support for outcome leads, engagement in the development process, participation in consultation and engagement and consideration of the budgetary impact on each organisation.
- 3.4 Each of the stages of the delivery plan development will inform the subsequent stage. The findings of the Economic Development Action Plan area workshops in October will inform the Area Community Planning Events. The findings from the Outcome Lead Workshops will also inform the Area Community Planning Events. The findings from the Area Community Planning Events will provide the outcome leads with community and stakeholder consultation and engagement information that will inform their draft delivery plans. All of this local area consultation will then inform the full partnership/population summit, which will in turn influence the final SOA delivery plan.
- 3.5 Discussion and agreement on resource planning will be one of the most significant areas for discussion amongst partners. As the budget preparation process begins, consideration must be given to the approach that each partner will take in aligning resources to the SOA and delivery of the key outcomes. Each partner will be responsible for ensuring that they can clearly align their resource commitment to SOA delivery.

#### 4 CONCLUSION

4.1 The Community Planning Partnership is focused on taking forward the five areas for improvement outlined by the quality assurance team with a view to having an agreed SOA with delivery plans finalised by February 2013. There will be significant resource requirement by partners to ensure that this target is met and significant challenges in aligning resources with SOA outcome delivery.
